A FINANCE BILL

TO ALLOCATE A MAXIMUM OF FIVE THOUSAND FOUR HUNDRED DOLLARS AND ZERO CENTS (\$5,400.00) FROM THE STUDENT GOVERNMENT LEGISLATIVE CONTINGENCY ACCOUNT TO FUND THE REGISTRATION OF A MAXIMUM OF SIXTY STUDENTS FROM THE LOUISIANA STATE UNIVERSITY SCHOOL OF VETERINARY MEDICINE TO ATTEND SAVMA SYMPOSIUM AT TEXAS A&M, MARCH 16-18

- PARAGRAPH 1:** WHEREAS, SAVMA SYMPOSIUM IS AN ANNUAL EDUCATIONAL EVENT HOSTED BY AND FOR VETERINARY STUDENTS IN THE UNITED STATES; AND
- PARAGRAPH 2:** WHEREAS, ATTENDING SAVMA SYMPOSIUM ALLOWS LOUISIANA STATE UNIVERSITY SCHOOL OF VETERINARY MEDICINE STUDENT CHAPTER MEMBERS OF SAVMA TO ATTEND WETLABS TO ENHANCE THEIR CLINICAL AND SURGICAL SKILLS; AND
- PARAGRAPH 3:** WHEREAS, STUDENTS ATTENDING SYMPOSIUM WILL ATTEND LECTURES GIVEN BY NATIONALLY RECOGNIZED PROFESSIONALS IN THE FIELD OF VETERINARY MEDICINE TO FURTHER ENHANCE THEIR EDUCATION; AND
- PARAGRAPH 4:** WHEREAS, THE MAJORITY OF VETERINARY STUDENTS AT LOUISIANA STATE UNIVERSITY CHOOSE TO PRACTICE IN LOUISIANA TO SERVE AND HEAL THE ANIMALS IN LOCAL COMMUNITIES; AND
- PARAGRAPH 5:** WHEREAS, THE IMPROVEMENT OF VETERINARY MEDICINE IN OUR STATE IS PARAMOUNT TO HUMAN HEALTH THROUGH BIOSECURITY, FOOD SAFETY, AND RESEARCH; AND
- PARAGRAPH 6:** WHEREAS, THE REQUESTED FUNDS SHALL BE ALLOCATED AS FOLLOWS:
- REGISTRATION FEES: \$5,400.00
A. REGISTRATION FOR 60 PARTICIPANTS AT \$90.00 PER STUDENT

PARAGRAPH 7: THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT A MAXIMUM OF FIVE THOUSAND FOUR HUNDRED DOLLARS AND ZERO CENTS (\$5,400.00) FROM THE LEGISLATIVE CONTINGENCY ACCOUNT TO FUND THE REGISTRATION OF A MAXIMUM OF 60 STUDENTS THE LOUISIANA STATE UNIVERSITY SCHOOL OF VETERINARY MEDICINE TO ATTEND SAVMA SYMPOSIUM AT TEXAS A&M, AND

PARAGRAPH 8: BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO ALISA JONES, STUDENT GOVERNMENT FINANCIAL COORDINATOR, AND DR. NATALIE RADEMACHER, FACULTY ADVISOR OF SAVMA.

PARAGRAPH 9: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS ($2/3$) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL
