A FINANCE BILL

**TO ALLOCATE A MAXIMUM OF THREE THOUSAND NINE HUNDRED NINETY-
FOUR DOLLARS AND ZERO CENTS (\$3994.00) FROM THE LEGISLATIVE
CONTINGENCY ACCOUNT TO FUND THE ORGANIZATION FOR COLLEGES
AGAINST CANCER RELAY FOR LIFE EVENT ON MARCH 10, 2017**

- PARAGRAPH 1:** WHEREAS, RELAY FOR LIFE IS THE PRIMARY FUNDRAISING BRANCH OF THE AMERICAN CANCER SOCIETY; AND
- PARAGRAPH 2:** WHEREAS, THE LSU CHAPTER OF RELAY FOR LIFE IS A REGISTERED STUDENT ORGANIZATION AND IS REQUESTING FUNDING TO SUPPORT THEIR ANNUAL EVENT; AND
- PARAGRAPH 3:** WHEREAS, THIS EVENT SERVES AS A CELEBRATION TO RECOGNIZE CANCER SURVIVORS IN THE BATON ROUGE AREA AND TO REMEMBER THOSE WHO LOST THE BATTLE AGAINST CANCER; AND
- PARAGRAPH 4:** WHEREAS, RELAY FOR LIFE LSU IS NOT RECEIVING FUNDING FROM THE AMERICAN CANCER SOCIETY TO PUT ON THIS EVENT; AND
- PARAGRAPH 5:** WHEREAS, RELAY FOR LIFE LSU HAS HELD VARIOUS FUNDRAISING EVENTS THROUGHOUT THE ENTIRE ACADEMIC YEAR; AND
- PARAGRAPH 6:** WHEREAS, RELAY FOR LIFE LSU HAS ACTIVELY WORKED TO GET OTHER SPONSORS FROM THE BATON ROUGE AREA; AND
- PARAGRAPH 7:** WHEREAS, THE LSU CHAPTER OF RELAY FOR LIFE WILL BE MAKING NO PROFIT FROM THE EVENT, AS ALL PROCEEDS GO DIRECTLY TO THE AMERICAN CANCER SOCIETY; AND
- PARAGRAPH 8:** WHEREAS, THE REQUESTED FUNDS SHALL BE ALLOCATED AS FOLLOWS:

POLICE DETAIL FOR FOUR HOURS: \$328.00
FLOOD LIGHTING: \$498.00
FACILITY SERVICES FOR POWER BOARD AND TRASHCANS:
\$250.00
MANAGEMENT OF SOUND SYSTEM: \$959.00
MANAGEMENT OF AV SYSTEMS: \$1959.00

TOTAL SUM OF COSTS: \$3994.00

PARAGRAPH 9: THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT A MAXIMUM OF THREE THOUSAND NINE HUNDRED NINETY-FOUR DOLLARS AND ZERO CENTS (\$3994.00) FROM THE STUDENT GOVERNMENT LEGISLATIVE CONTINGENCY ACCOUNT BE ALLOCATED TO FUND THE LSU CHAPTER OF RELAY FOR LIFE'S ANNUAL EVENT, AND

PARAGRAPH 10: BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO ALISA JONES, STUDENT GOVERNMENT FINANCIAL COORDINATOR, AND CARLI BERSHON, EXECUTIVE DIRECTOR OF RELAY FOR LIFE LSU.

PARAGRAPH 11: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS ($2/3$) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL
