A FINANCE BILL

TO ALLOCATE A MAXIMUM OF ONE THOUSAND SIX HUNDRED NINETY-EIGHT DOLLARS AND SEVENTY-FIVE CENTS (\$1,698.75) FROM THE STUDENT SENATE INITIATIVES ACCOUNT TO FUND LSU'S DEPARTMENT TEXTILES, APPAREL, AND MERCHANDISING FOR NINE NEW SEWING MACHINE MOTORS

PARAGRAPH 1: WHEREAS, TEXTILES, APPAREL, AND MERCHANDISING HAS NINETEEN SEWING MACHINES AND ONLY TEN HAVE OPERATING MOTORS; AND

PARAGRAPH 2: WHEREAS, THE TAM DEPARTMENT CANNOT MAXIMIZE THE USE OF ALL MACHINES AND GIVE INSTRUCTORS THE ABILITY TO FILL CLASS CAPACITY; AND

PARAGRAPH 3: WHEREAS, THE TAM DEPARTMENT IS EXPERIENCING SLOWER GRADUATION RATES DUE TO THE LACK OF SEWING MACHINE MOTORS; AND

PARAGRAPH 4: WHEREAS, BUYING NINE NEW MOTORS WOULD ALLOW STUDENTS THE RESOURCES THEY NEED TO WORK ON PROJECTS AND COLLECTIONS OUTSIDE OF THE CLASSROOM, WHICH CAN BE BENEFICIAL FOR STUDENTS TO GET EXPERIENCE IN APPAREL DESIGN; AND

PARAGRAPH 5: WHEREAS THE APPROPRIATED FUNDS WILL BE ALLOCATED AS FOLLOWS:

- 1. NINE GBSM 550 BRUSHLESS SERVO MOTORS**
 - a. $9 \times \$130 = \$1,170.00$**
 - 2. SHIPPING AND HANDLING**
 - a. \$78.75**
 - 3. LABOR TO INSTALL SERVO MOTORS**
 - a. \$450.00**
- TOTAL: \$1,698.75**

PARAGRAPH 6: THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT A MAXIMUM OF ONE THOUSAND SIX HUNDRED NINETY-EIGHT DOLLARS AND SEVENTY-FIVE CENTS (\$1,698.75) BE ALLOCATED FROM THE STUDENT GOVERNMENT INITIATIVES ACCOUNT TO FUND NINE SEWING MACHINE MOTORS FOR THE LSU TAM DEPARTMENT, AND

PARAGRAPH 7: BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO ALISA JONES, STUDENT GOVERNMENT

FINANCIAL COORDINATOR; DR. JENNA KUTTRUFF, TAM DEPARTMENT HEAD; AND ELVA BOURGEOIS, TAM UNDERGRADUATE COORDINATOR AND SENIOR INSTRUCTOR.

PARAGRAPH 8:

THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL
