**A FINANCE BILL**

**TO ALLOCATE A MAXIMUM OF SIXTEEN THOUSAND FIVE HUNDRED DOLLARS AND ZERO CENTS (\$16,500) FROM THE STUDENT SENATE SURPLUS ACCOUNT TO FUND FIFTEEN (15) WATER BOTTLE FILLING STATIONS TO BE INSTALLED IN FIFTEEN BUILDINGS ON CAMPUS**

**PARAGRAPH 1:** WHEREAS, LOUISIANA STATE UNIVERSITY STUDENT SENATE WILL FUND FIFTEEN WATER BOTTLE FILLING STATIONS TO BE INSTALLED IN VARIOUS LOCATIONS AROUND CAMPUS; AND

**PARAGRAPH 2:** WHEREAS, DUE TO THE POPULARITY OF THESE WATER BOTTLE FILLING STATIONS, INSTALLING ONE FILLING STATION IN EACH OF THE FOLLOWING BUILDINGS (MUSIC AND DRAMATIC ARTS BUILDING, SCHOOL OF MUSIC BUILDING, ENERGY COAST AND ENVIRONMENT BUILDING, HUMAN ECOLOGY BUILDING, MANSHIP SCHOOL OF MASS COMMUNICATION – JOURNALISM BUILDING, BUSINESS EDUCATION COMPLEX ROTUNDA, LSU SCHOOL OF VETERINARY MEDICINE, LSU SCHOOL OF RENEWABLE NATURAL RESOURCES, FRENCH HOUSE - OGDEN HONORS COLLEGE, PAUL M. HEBERT LAW CENTER, STURGIS HALL, WOODIN HALL, J.C. MILLER HALL, COATES HALL, AND THOMAS D. BOYD HALL) WILL ACCOMMODATE THE NEEDS OF MORE STUDENTS THROUGHOUT THE CAMPUS; AND

**PARAGRAPH 3:** WHEREAS, FUNDS FOR THESE WATER BOTTLE FILLING STATIONS SHALL BE ALLOCATED AS FOLLOWS:

1. FIFTEEN (15) 60HZ PUSHBAR VP STREAMSAVER BUBBLER DRINKING FOUNTAIN WITH FILTER AND EZH2O STATION - \$16,500.00
  - A. EACH WATER BOTTLE FILLING COST - \$1,100
  - B. ONE WATER BOTTLE FILLING STATION WILL BE INSTALLED IN FIFTEEN DIFFERENT ACADEMIC BUILDING AROUND CAMPUS

**PARAGRAPH 4:** THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT A MAXIMUM OF \$16,500.00 BE ALLOCATED FROM THE STUDENT SENATE SURPLUS ACCOUNT TO FUND FIFTEEN (15) WATER BOTTLE FILLING STATIONS, AND

**PARAGRAPH 5:** BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO Ms. ALISA JONES, STUDENT GOVERNMENT FINANCIAL COORDINATOR AND TAMMY MILLICAN, ASSISTANT DIRECTOR OF FACILITY SERVICES

**PARAGRAPH 6:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL
