7 A BILL

8 TO AMEND THE STUDENT GOVERNMENT RULES OF COURT

9 PARAGRAPH 1: WHEREAS, THIS AMENDMENT WILL REQUIRE THE JUSTICES TO BE
10 TRAINED AS UNIVERSITY HEARING PANELISTS (UHP); AND

11 PARAGRAPH 2: WHEREAS, THIS WILL ALLOW FOR THE MEMBERS OF THE
12 JUDICIAL BRANCH TO BECOME MORE INVOLVED WITH THE
13 OFFICE OF STUDENT ADVOCACY AND ACCOUNTABILITY; AND

14 PARAGRAPH 3: WHEREAS, THE JUDICIAL BRANCH HAS ALREADY APPROVED THIS
15 AMENDMENT; AND

16 PARAGRAPH 4: WHEREAS, THE STUDENT GOVERNMENT RULES OF COURT SHALL
17 READ AS FOLLOWS:

18 Article II

19 Judicial Branch Membership

20 Section 6. Responsibilities of the Associate Justices


- 21 A. Associate Justices shall be responsible for attending meetings or hearings called to order by the
22 Chief Justice.
- 23 B. Associate Justices shall adhere to attendance policies as stated in Article I, Section 1§B of the
24 Rules of Court.
- 25 C. All Associate Justices of the University Court must attend at least two (2) Senate or Executive
26 Staff meetings and two (2) Student Outreach Events per semester. Student Outreach Events shall
27 be determined at the discretion of the Chief Justice. Proof of attendance shall be sent to the
28 Clerk(s) of Court by sgclerk@lsu.edu no later than forty-eight (48) hours after the event was held.
29 1. Any staff member of the Judicial Branch can submit a request for approval for any
30 outside event to sgjudicial@lsu.edu at least two (2) days prior to the event.
- 31 D. All Associate Justices must demonstrate knowledge of all Student Government Governing
32 Documents and impartiality throughout their term of office.
- 33 E. No member of or candidate for position within the Judicial Branch shall help, assist, serve on,
34 campaign for or advise any Fall or Spring Student Government Campaign or Ticket. 84.
- 35 F. Each Justice shall be assigned to attend and report on at least one of the following Student
36 Government Meetings at the next regularly scheduled Judicial Branch meeting.
37 1. Student Senate Meeting
38 2. Executive Branch Staff Meeting
39 3. Programming, Support, and Initiatives Fund Meetings
40 4. College Council Presidents' Cabinet Meetings
- 41 G. Each Justice shall be trained as a University Hearing Panelist (UHP) in conjunction with the
42 Office of Student Advocacy & Accountability and must serve on at least three (3) panels per
43 semester.
44 1. Justices may also be trained as Alternative Hearing Panelists (AUHP) or Residential
45 Life Panelists (RLP). These panels shall serve as viable substitutes to participation
46 in a UHP.

58 **PARAGRAPH 5:** THEREFORE, BE IT ENACTED BY THE LOUISIANA
59 STATE UNIVERSITY STUDENT SENATE THAT THE ABOVE
60 AMENDMENTS ARE ADOPTED INTO THE LSU STUDENT
61 GOVERNMENT RULES OF COURT, AND

63 **PARAGRAPH 6:** BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL
64 BE TRANSMITTED TO DR. MATT GREGORY, JUDICIAL
65 BRANCH ADVISOR.

67 **PARAGRAPH 7:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A THREE-
68 FOURTHS (3/4) VOTE OF THE LSU STUDENT SENATE AND
69 SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR
70 PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND
71 SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF
72 SUCH APPROVAL.
