8 TO AMEND THE STUDENT GOVERNMENT BYLAWS.

12 **PARAGRAPH 1:** WHEREAS, ALL MEMBERS OF LSU STUDENT GOVERNMENT (SG)
13 WILL BE REQUIRED TO VOLUNTEER AT TWO (2) SG EVENTS AND
14 TO COMPLETE TWO (2) ORGANIZATION VISITS PER SEMESTER; AND

16 **PARAGRAPH 2:** WHEREAS, POSSIBLE SG EVENTS INCLUDE, BUT ARE NOT LIMITED
17 TO: TABLE SITS, GROOVIN', THE COLLEGE COUNCIL LECTURE
18 SERIES, INFORMATION FAIRS AND OTHER SG SPONSORED EVENTS;
19 AND

21 **PARAGRAPH 3:** WHEREAS, APPROVAL OF OTHER EVENTS IS AT THE DISCRETION
22 OF THE OUTREACH COORDINATOR FOR EACH OF THE BRANCHES;
23 AND

25 **PARAGRAPH 4:** WHEREAS, THIRTY (30) MINUTES OF VOLUNTEERING
26 CONSTITUTES WORKING ONE (1) EVENT; AND

28 **PARAGRAPH 5:** WHEREAS, A MEMBER OF SG WILL NO LONGER BE ALLOWED TO
29 GET MORE THAN ONE (1) POINT AT A SINGLE EVENT; AND

30
31 **PARAGRAPH 6:** WHEREAS, AN ORGANIZATION VISIT REQUIRES A MEMBER OF SG
32 TO ATTEND THE MEETING OF THE ORGANIZATION TO FIND OUT
33 HOW SG CAN HELP THE ORGANIZATION, EITHER BY FUNDING,
34 PROMOTING OR ATTENDING EVENTS, AND TO TALK ABOUT
35 AVAILABLE OPPORTUNITIES WITHIN SG AND SG EVENTS; AND

37 **PARAGRAPH 7:** WHEREAS, A MEMBER OF SG WILL NOT BE LIMITED TO ONLY ONE
38 (1) ORGANIZATION TO COMPLETE THIS REQUIREMENT; AND

40 **PARAGRAPH 8:** WHEREAS, EACH MEMBER OF SG WILL BE REQUIRED TO FULFILL
41 ANY ONE (1) OF THESE REQUIREMENTS PER THREE (3)
42 LEGISLATIVE WEEKS; AND

43
44 **PARAGRAPH 9:** WHEREAS, EACH MEMBER OF SG MUST RECORD THEIR
45 PARTICIPATION BY THE DUE DATE OF EACH POINT.

47 **PARAGRAPH 10:** THE BYLAWS SHALL BE AMENDED TO READ AS FOLLOWS:

49 Article III Section 1D

51 ~~Each Senator~~ **All members of LSU Student Government (SG)**
52 **must obtain a minimum of three (3) two (2) student outreach**
53 **points and attend two (2) organization visits per semester. in a**

54 ~~minimum two (2) events.~~

56 One (1) student outreach point is equal to **working at one (1)**
57 **event approved by the Chair of Student Life, Diversity and**
58 **Community Outreach Committee. An organization visit**
59 **requires a member of SG to attend the meeting of the**
60 **organization and to inform them of the opportunities and**
61 **support available through SG. ~~thirty (30) minutes of Student~~**
62 **~~Outreach service work or one organizational visit other than an~~**
63 **~~organization that the Senator is currently involved in.~~**

64
65 Each Senator must obtain their first student outreach point by
66 the ~~fourth (4th)~~ **third (3rd)** legislative week, the second by the
67 ~~eighth (8th)~~ **the sixth (6th)**, and the third by the ~~twelfth (12th)~~
68 **ninth (9th) and the fourth by the twelfth (12th).**

69
70 1. If appointed before the ~~fourth (4th)~~ **third (3rd)** and the
71 **sixth (6th)** legislative week, the Senator must only obtain ~~two~~
72 **(three)** student outreach points by the end of the semester.

73
74 2. If appointed before the ~~eighth (8)~~ **sixth (6th)** and the
75 **ninth (9th)** legislative week, the Senator must only obtain ~~one~~
76 **two** student outreach points by the end of the semester.

79 3. **If appointed before the ninth (9th) legislative week,**
80 **the Senator must only obtain one student outreach point by**
81 **the end of the semester.**

82
83 4. If appointed after the ~~eighth (8)~~ **ninth (9th)** legislative
84 week, the Senator is not required to participate in any student
85 outreach events.

86 The proposed event must be presented to the Chair and Vice-
87 Chair of the Student Life, Diversity and Community Outreach
88 Committee no later than two (2) days before event takes place.

89
90 Events other than specifically stated Student Outreach Events
91 must be approved unanimously by the Chair and Vice-Chair of
92 the Student Life, Diversity and Community Outreach
93 Committee.

94
95 A Senator must notify an event coordinator that he or she can no
96 longer attend the event with at least twenty-four (24) hours
97 notice if he or she has made an express commitment to attend the
98 event. If notification is not received and a Senator does not fulfill
99 their commitment, the Senator will be required to obtain an
100 additional Student Outreach point. Extreme medical, weather,
101 and familial instances will be considered by the Speaker.



PARAGRAPH 11: THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT THE ABOVE AMENDMENTS BE ADOPTED INTO THE LSU STUDENT GOVERNMENT BYLAWS, AND


PARAGRAPH 12: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO THE LSU STUDENT GOVERNMENT PRESIDENT AND VICE PRESIDENT, THE SPEAKER OF LSU STUDENT GOVERNMENT SENATE AND THE LSU STUDENT GOVERNMENT CHIEF JUSTICE.

PARAGRAPH 13: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
