9 **A FINANCE BILL**

10 **TO ALLOCATE A MAXIMUM OF THREE THOUSAND FIVE HUNDRED DOLLARS AND ZERO**
11 **CENTS (\$3,500.00) FROM THE STUDENT GOVERNMENT LEGISLATIVE CONTINGENCY**
12 **ACCOUNT TO FUND FLOWERS AND AN IRRIGATION SYSTEM IN FRONT OF A LOUISIANA**
13 **STATE UNIVERSITY SIGN**

15 **PARAGRAPH 1:** WHEREAS, THE LOUISIANA STATE UNIVERSITY SIGN AT THE
16 CORNER OF SOUTH STADIUM DR AND LAKESHORE DR IS
17 CURRENTLY SURROUNDED BY WEEDS; AND

19 **PARAGRAPH 2:** WHEREAS, THE FLOWERS PLANTED IN PLACE OF THE WEEDS
20 WOULD ENHANCE THE BEAUTY OF THE CAMPUS; AND

22 **PARAGRAPH 3:** WHEREAS, THESE FLOWERS COULD HELP ATTRACT POTENTIAL
23 STUDENTS; AND

25 **PARAGRAPH 4:** WHEREAS, IN ORDER TO MAINTAIN THE FLOWERS, THE PURCHASE
26 AND INSTALLATION OF AN IRRIGATION SYSTEM IS REQUIRED; AND

28 **PARAGRAPH 5:** WHEREAS, THE FUNDS SHALL BE ALLOCATED AS FOLLOWS:

30 1. FLOWERS (\$1,000)
31 2. IRRIGATION SYSTEM (\$2,500)
32 TOTAL: \$3,500.00

34 **PARAGRAPH 6:** THEREFORE, BE IT ENACTED BY THE LOUISIANA
35 STATE UNIVERSITY STUDENT SENATE THAT A MAXIMUM
36 OF THREE THOUSAND FIVE HUNDRED DOLLARS AND ZERO CENTS
37 (\$3,500.00) BE ALLOCATED FROM THE STUDENT GOVERNMENT
38 LEGISLATIVE CONTINGENCY ACCOUNT TO FUND FLOWERS AND
39 AN IRRIGATION SYSTEM IN FRONT OF A LOUISIANA STATE
40 UNIVERSITY SIGN; AND

42 **PARAGRAPH 7:** BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL
43 BE TRANSMITTED TO ALISA JONES, STUDENT GOVERNMENT
44 FINANCIAL COORDINATOR, AND TAMMY MILLICAN, ASSISTANT
45 DIRECTOR TO FACILITY SERVICES; AND

47 **PARAGRAPH 8:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS
48 (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY
49 THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL
50 ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY
51 APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
