**A RESOLUTION**

**TO URGE AND REQUEST THE FORMATION OF A STUDENT COMMITTEE TO  
PROVIDE INPUT ON LIBRARY RENOVATIONS AND OTHER SERVICES OFFERED BY  
THE LIBRARY**

- PARAGRAPH 1:** WHEREAS, DEAN WILDER, THE DEAN OF LSU LIBRARIES, IS REQUESTING THE FORMATION OF A STUDENT COMMITTEE FOR LIBRARY RENOVATIONS AND OTHER SERVICES OFFERED BY THE LIBRARY; AND
- PARAGRAPH 2:** WHEREAS, THE FORMATION OF THIS COMMITTEE WOULD ALLOW FOR THE VOICE OF STUDENTS IN THE PROCESS OF RENOVATIONS AND IN THE CURRENTLY IMPLEMENTED AND POSSIBLY FUTURE SERVICES OFFERED BY THE LIBRARY; AND
- PARAGRAPH 3:** WHEREAS, THE INPUT OF STUDENTS WILL BE NECESSARY IN THIS PROCESS, AS THE PURPOSE OF THESE RENOVATIONS AND SERVICES IS TO BENEFIT THE STUDENT BODY; AND
- PARAGRAPH 4:** WHEREAS, THESE COMMITTEE MEMBERS, APPOINTED BY THE CHAIR OF THE ACADEMIC AFFAIRS COMMITTEE, SHALL CONVENE WITH THE DEAN ONCE OR TWICE EVERY SEMESTER; AND
- PARAGRAPH 5:** WHEREAS, THIS COMMITTEE SHALL EXIST UNTIL THE COMPLETION OF LSU'S NEW LIBRARY OR AS LONG AS THE DEAN DEEMS IT NECESSARY; AND
- PARAGRAPH 6:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT THE STUDENT SENATE STANDS IN FULL SUPPORT OF THE FORMATION OF THE PROPOSED LIBRARY COMMITTEE, AND
- PARAGRAPH 7:** BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO STANLEY WILDER, DEAN OF LSU LIBRARIES, AND JASON BADEAUX, STUDENT BODY PRESIDENT.
- PARAGRAPH 8:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
