 - THIS WOULD BE A BUS THAT WE COULD PULL FROM

 - WE ANALYZED WHICH ONES HAD THE LOWEST NUMBER OF RIDERS DURING THE DAY
 - THAT'S WHY THEY CHOSE THAT SPECIFIC ROUTE
 - SEN. BLACK: WOULD THIS CHANGE ANY OF THE STOPS?
 - THE ONLY PART IS THE BUS ROUTE FOR PURPLE UNION
 - ALL THE STOPS WOULD BE HIT BY PURPLE 2
 - LOCKETT WILL NOT BE AFFECTED

 - SEN. GRASHOFF:
 - PASSED IN COMMITTEE 10-0-2
 - SOME MINOR CHANGES: WORDING AND GRAMMAR
 - SEN. EL RACHIDI:
 - HAD A MEETING WITH JEFF CAMPBELL
 - THE ONLY ISSUE THAT HE HAD WAS THE IDEA THAT IT WAS GOING TO HAPPEN INSTANTLY
 - JEFF WAS IN FAVOR BUT HE STILL HAD TO LOOK AT THE REST OF THE DETAILS AND INFRASTRUCTURE
 - IN FAVOR OF THIS BILL
 - SEN. ACCARDO:
 - IT WAS NEVER COMPLETELY EMPTY
 - THE REPORT IS PRETTY OFF
 - A LOT OF GRAD SCHOOL STUDENTS LIVE IN THAT AREA AND THEY TEACH CLASS
 - THAT'S THEIR TRANSPORTATION TO SCHOOL
 - TIGERLAND A OR B ISN'T THE ONE
 - SHOULD BE REWRITTEN A LITTLE DIFFERENTLY
 - THESE AFFECT THE STUDENTS WHO LIVE IN THE AREA, BUT THEY CAN WALK TO CAMPUS
 - BRIGHTSIDE STUDENTS NEED THAT BUS TO GET TO CLASS – THEY CAN'T WALK
 - SEN. JOYNER:
 - IN FAVOR OF THE BILL
 - AVID USERS OF THE BUS
 - THE BUS REACHES MAXIMUM CAPACITY A LOT
 - IT WOULD BE BENEFICIAL THAT THERE IS ANOTHER PURPLE BUS
 - SEN. DUPLESSIS:
 - THERE A LOT OF PEOPLE AT THOSE STOPS
 - IT'S A GOOD IDEA TO CUT CONGESTION
 - THE A & B BUS RUN THE SAME BUS AND HIT EVERY 12 MINUTES
 - SEN. BORNE:
 - IT'S HELPFUL
 - THERE ARE MAJOR ISSUES WITH OCCUPANCY AND IT'S A SAFETY ISSUE
