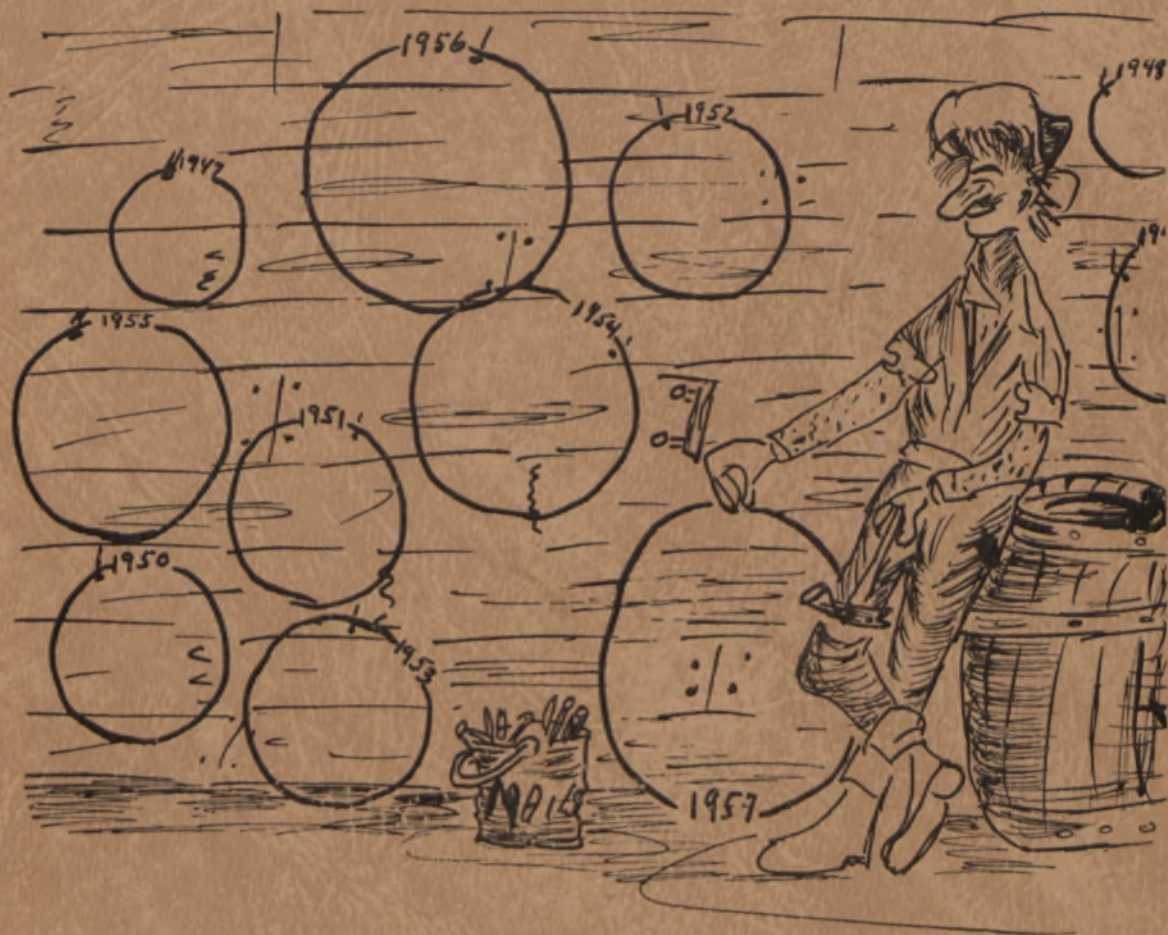

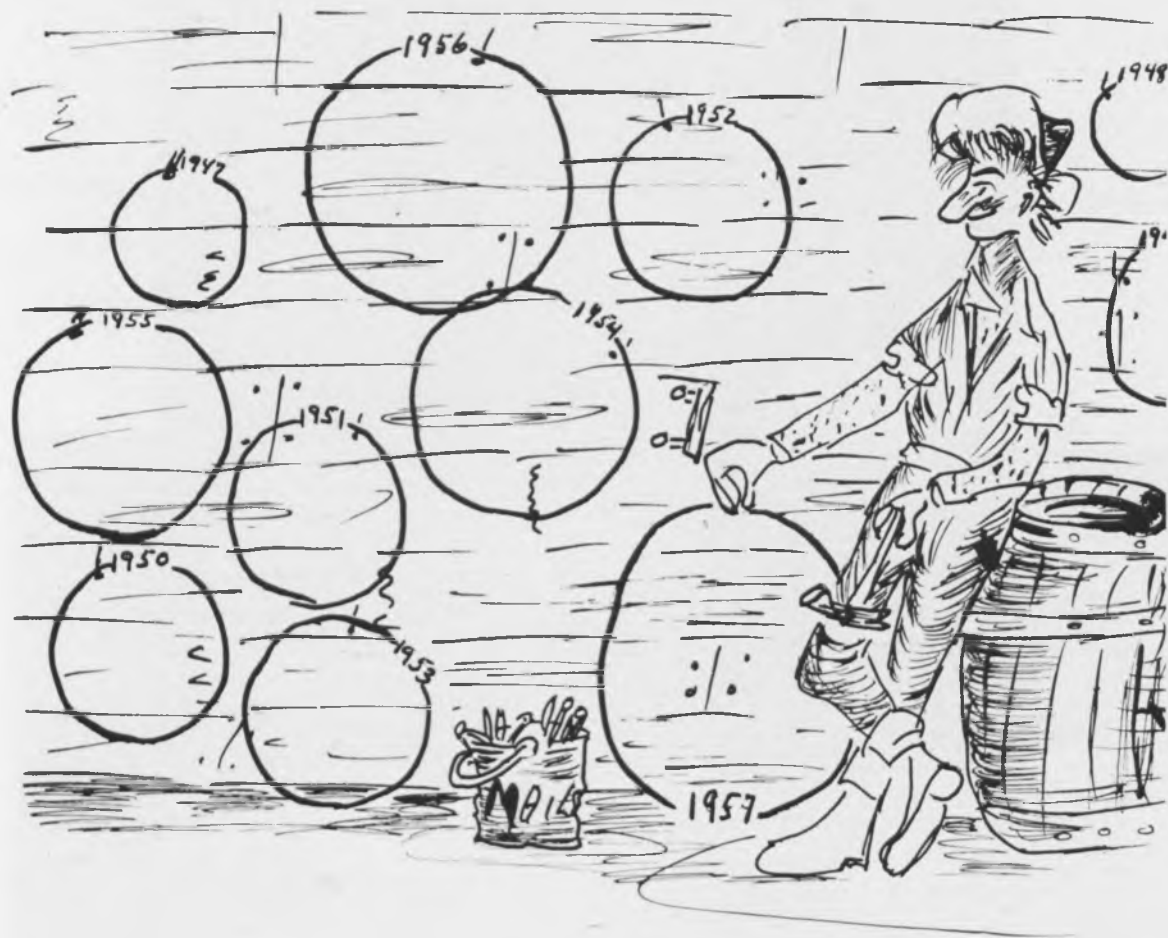

# THE DIRECTOR'S MESSAGE

Dear Alumni:

We have now had our new Forestry Building one year, and we feel that the building is helping to publicize forestry on the campus, as well as serving our needs for space admirably. Many visitors look the building over while they are on the campus, including those who are connected with the forestry profession and those who are not. In March and April we had a large and attractive display featuring southern hardwoods in our lobby.

Enrollment increased again this year. The outstanding gain was in number of graduate students. In the spring of 1957, there were 16 students enrolled for the M.F. and 7 for the M.S. in Game Management. Five men received the B.S.F. in January, 1957; we expect that 16 seniors will be graduated in June and 5 in August.

Professor Robert W. McDermid took leave this year to work on a Ph.D. in economics at Tulane. In February, 1957, Dr. Frank R. Moulds joined the staff to serve as Visiting Professor for one semester while on leave from his post as head of the Victorian School of Forestry in Australia. Professor M. B. Applequist returned from his sabbatical leave at Duke and resumed his duties last September. Professor A. B. Crow finished teaching his graduate extension course in silviculture at Bogalusa; he then responded to the demand for the course by central Louisiana foresters and taught it in Alexandria.

The staff has been active in publishing articles in various journals. The *Journal of Forestry* carried articles by Professors McDermid and Hansbrough, *The Forest Farmer* an article by Burns, and the *Journal of Wildlife Management* an article by Glasgow. L.S.U. Forestry Notes 8 through 14 appeared during the year, written by various staff members. Bryant A. Bateman read a paper at the 1956 S.A.F. meeting, and Ralph W. Hayes wrote a bulletin on pulpwood economics.

Alumni support of the School has been excellent. The annual Alumni Association meeting was marked by a spirit of enthusiasm, and a fund was started to raise money for improving the physical facilities of the School. Students and faculty are grateful for this loyal support.

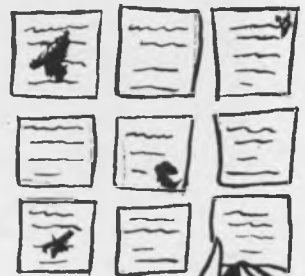
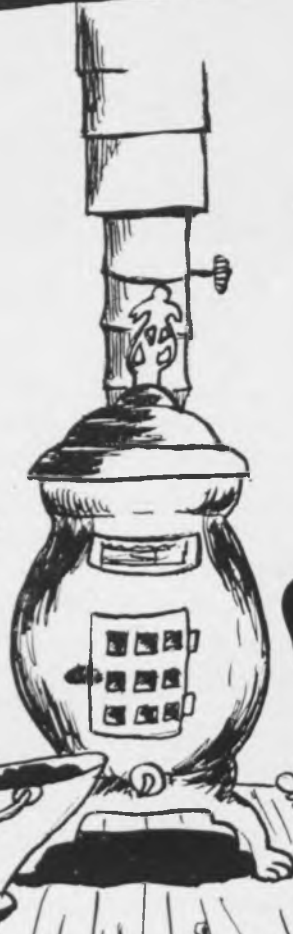

The Chapter sponsors an award that goes to the Outstanding Sophomore of the previous year; included with this award is a \$50 scholarship, financed by the alumni previously named.

11. The Christmas Cone Sale of pine cones and mistletoe netted \$40. The program could be expanded greatly and greater profit might be shown.
12. The lounge has been furnished with the generous help of the Alumni Association and is enjoyed by all.
13. The Rodeo this year netted the club only approximately one-half of what it did last year. This should have been increased and in the future greater effort should be made to take maximum advantage of this opportunity to make money.

# SUMMER CAMP

Summer camp started off with a new twist this year. For the first time in the history of the School, part of the camp was held at a location other than the School Forest.

The first three weeks of camp were held at the state forest at Woodworth, La. On Monday, June 4, twenty-one students turned out for the start of a summer that would not soon be forgotten. The first week, dendrology, consisted of conducted tours under the guidance of Prof. Hansbrough, in an extended search for exotic species. After one look at the snake situation, every one agreed that "Tiny" Jerry Toney had at last come home and that he would be well entertained for the next few weeks. During the week we had ample evidence of Toney's snake handling ability and also of Huey "Wild Man" Lizana's prowess as a knife thrower. No one wanted to say that Huey was lucky, but some talk was heard about him quitting after the first time he hit anything. The most excitement so far was provided when Lefty "Big Foot" Schwartz tried to prove that the best way to kill snakes is by walking on them. On Thursday, the boy foresters got their first taste of TSI work. Accompanied by a loud cry of "We don't care about axe handles, we just want to kill trees!", an effective demonstration was provided, and following this, the boys, led by Phil "Little Beaver" Holland and Jay "Hawk Trainer" Wright, went to work with little beaver, axe, and bazooka. George "Rosie" Rosentreter became the first casualty after being viciously attacked by a yellow-jacket, but he quickly received adequate first aid from Dr. Hansbrough and his assistant, Dr. Willie J. "Crossroads, Here I Come" Smith. The week ended with a sudden death dendro

test lasting all day Friday, followed by a mass retreat home by the married men, with Earl "Don't Ask Me If I'm Going To Slidell This Weekend" Broom far in the lead.

The second and third weeks of camp consisted of silviculture under Prof. Crow. During the first part of the course the class put in some of the most costly plots ever established west of the Mississippi River. "Better things" included a trip to Mr. Charlie Lewis's direct seeding areas, a mass cruise of a slash pine plantation under the direction of Mr. Bill Mann and numerous Crow-special cut or leave tests. The rest of the week was passed playing an interesting game called "Where Am I?" led by Dr. Burns, and taking quick tests on about 20 chapters of text-book material at a time. The major complaint of the week came from Brother Jim "Shake That Tree Again" Lyon. He said that Dr. Burns just wouldn't cooperate with him in locating those trees on the aerial photos.

The sixth week saw us back at mensuration under Prof. Briscoe. We continued our cruises and reports. The week saw an outing of the L.S.U. Forestry softball team when, led by the hitting of Bob "Blabbermouth" Asseff, they lost a close one to the Mount Herman Milkers by a score of 17 to 16. twice. The week and mensuration ended with one of Prof. Briscoe's tests that left everybody gasping.

The next week was called forest engineering, under Prof. McDermid. It was during this week that, with the help of Hoodlum's Haven, the stakebody truck got the fanciest set of white-sidewall tires in Washington Parish. The week was devoted to land-line surveys and the like and was ended Friday when the Prof. broke up the class and sent them to the four points of the compass to conduct individual cruises on twenty-acre tracts. After expressing their surprise at seeing him back so early, the rest of the class took off for the weekend, leaving him to finish up.

After cutting and winching them down, they were hauled to the L.S.U. Wedge Mill where, with Prof. Hopkins as sawyer, they were sawn into lumber? During the latter part of the week the engineers, under Prof. McDermid, built a bridge—probably the only bridge in the state with absolutely no roads or trails leading to it. Friday, the last of camp, was spent in cleaning and packing equipment. As the final whistle blew and the mass exodus home started, everyone agreed that it had been fun, but no tears seemed to be shed over leaving.

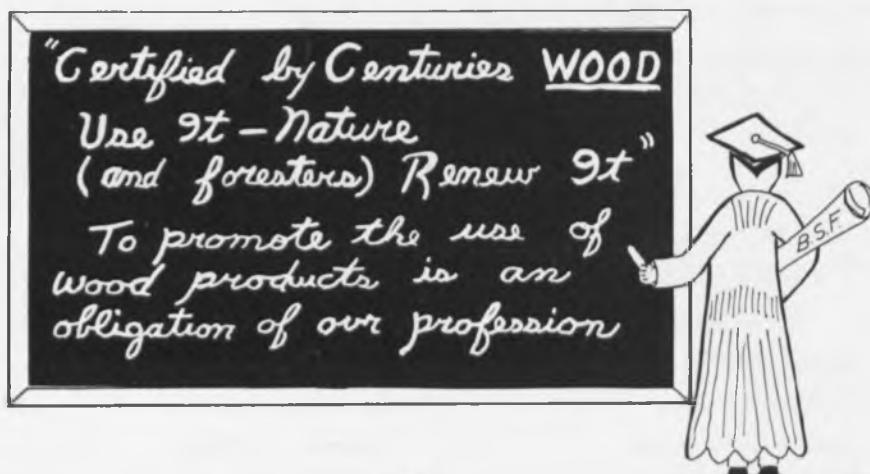

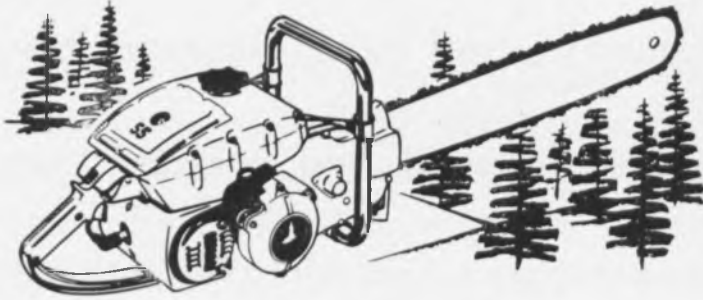
