A RESOLUTION

TO CONGRATULATE AND COMMEND DR. WILLIAM "BILL" DALY ON
COMMITTING 50 YEARS OF SERVICE TO LOUISIANA STATE UNIVERSITY

- PARAGRAPH 1:** WHEREAS, DR. DALY IS RESEARCH ORIENTED AND WORKS WITH OTHER INDIVIDUALS TO INVESTIGATE TOPICS RELATING TO IMPROVING PERSONAL CARE PRODUCTS; AND

- PARAGRAPH 5:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT DR. WILLIAM "BILL" DALY IS CONGRATULATED AND COMMENDED FOR COMMITTING 50 YEARS OF SERVICE TO LOUISIANA STATE UNIVERSITY, AND
