A RESOLUTION

**TO COMMEND AND HONOR LES MILES FOR HIS YEARS OF SERVICE AS HEAD
COACH TO THE LOUISIANA STATE UNIVERSITY FOOTBALL PROGRAM**

- PARAGRAPH 1:** WHEREAS, COACH LES MILES HONORABLY SERVED LOUISIANA STATE UNIVERSITY AS HEAD COACH FOR 12 YEARS OF SUSTAINED EXCELLENCE; AND
- PARAGRAPH 2:** WHEREAS, UNDER COACH MILES' LEADERSHIP, LSU WAS EXTREMELY SUCCESSFUL, HAVING WON TWO (2) SEC CHAMPIONSHIP TITLES (2007, 2011), ONE (1) NATIONAL CHAMPIONSHIP (2007), AND POSTING AN ASTOUNDING RECORD OF 114-34; AND
- PARAGRAPH 3:** WHEREAS, COACH MILES PLAYED A DIRECT ROLE IN THE DEVELOPMENT OF STUDENT ATHLETES, WITH 242 FOOTBALL PLAYERS HAVING EARNED THEIR DEGREES; AND
- PARAGRAPH 4:** WHEREAS, LSU RANKED SECOND IN THE SEC IN TWO OUT OF THE LAST FOUR (2/4) YEARS IN GRADUATION RATES UNDER COACH MILES; AND
- PARAGRAPH 5:** WHEREAS, LSU HAS PRODUCED 187 PLAYERS THAT HAVE EARNED SEC ACADEMIC HONOR ROLL STATUS UNDER MILES' LEADERSHIP; AND
- PARAGRAPH 6:** WHEREAS, MILES' EFFORTS HAVE CONTRIBUTED TO LSU'S REMARKABLE SUCCESS AT PRODUCING HIGHLY RECOGNIZED NFL PLAYERS.
- PARAGRAPH 7:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT COACH LES MILES BE HONORED AND COMMENDED FOR HIS YEARS OF SERVICE TO THE UNIVERSITY AND THAT HE FOREVER BE RECOGNIZED AS A VALUED MEMBER OF THE BATON ROUGE COMMUNITY, AND

PARAGRAPH 8: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO COACH LES MILES AND THE LSU ATHLETIC DEPARTMENT.

PARAGRAPH 9: THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
