### A RESOLUTION

TO HONOR DR. T. GILMOUR REEVE FOR HIS MANY YEARS OF SERVICE AS A  
PROFESSOR & VICE PROVOST OF LOUISIANA STATE UNIVERSITY

- PARAGRAPH 1:** WHEREAS, DR. REEVE HAS SERVED LSU AS THE VICE PRESIDENT FOR INSTITUTIONAL EFFECTIVENESS AND ACADEMIC PLANNING AND AS A PROFESSOR OF KINESIOLOGY; AND
- PARAGRAPH 2:** WHEREAS, HE HAS SERVED AS PRESIDENT OF FOUR NATIONAL ORGANIZATIONS: THE AMERICAN KINESIOLOGY ASSOCIATION (2009-2011); THE RESEARCH CONSORTIUM OF THE AMERICAN ALLIANCE FOR HEALTH, PHYSICAL EDUCATION, RECREATION AND DANCE (2008-2009); THE AMERICAN ACADEMY FOR KINESIOLOGY AND PHYSICAL EDUCATION (NOW THE NATIONAL ACADEMY OF KINESIOLOGY) (2004-2005), AND THE NORTH AMERICAN SOCIETY FOR THE PSYCHOLOGY OF SPORT AND PHYSICAL ACTIVITY (1991-1992); AND
- PARAGRAPH 3:** WHEREAS, PRIOR TO COMING TO LSU, HE SERVED AS THE CHAIR OF THE DEPARTMENT OF HEALTH, EXERCISE, AND SPORT SCIENCES (1999-2004) AND AS DIRECTOR OF STRATEGIC PLANNING (2002-2008) IN THE PRESIDENT'S OFFICE AT TEXAS TECH UNIVERSITY, AS WELL AS HAVING TAUGHT AT AUBURN UNIVERSITY FOR 22 YEARS, EARNING THE AUBURN ALUMNI PROFESSORSHIP (1991-1996) AND THE W. T. SMITH DISTINGUISHED PROFESSORSHIP IN EDUCATION (1998-1999).
- PARAGRAPH 4:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT DR. T. GILMOUR REEVE BE RECOGNIZED FOR HIS SERVICE TO LOUISIANA STATE UNIVERSITY, AS WELL AS HIS MANY OUTSTANDING ACCOMPLISHMENTS THROUGHOUT HIS CAREER, AND
- PARAGRAPH 5:** BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO DR. T.

GILMOUR REEVE AND THE DEAN OF THE COLLEGE OF SCIENCE, DR. CYNTHIA PETERSON.
