A RESOLUTION

**TO URGE AND REQUEST THE OFFICE OF THE DEAN OF STUDENTS,
DEPARTMENT OF ATHLETICS, AND LSU POLICE DEPARTMENT TO
COMMUNICATE AND ENFORCE PROPER CARE FOR PETS DURING TAILGATING
AND OTHER EVENTS**

PARAGRAPH 1: WHEREAS, DURING TAILGATES AND OTHER GAME DAY EVENTS MANY PETS ARE LEFT WITHOUT PROPER SHELTER AND WATER WHICH CAUSES UNNECESSARY SUFFERING BY THE ANIMAL; AND

PARAGRAPH 2: WHEREAS, SUPPLEMENTAL TRAINING FOR LSU POLICE IN REGARDS TO WHAT IS PROPER PET CARE AS DEFINED BY LOUISIANA'S TITLE XIV AND HOW TO ENFORCE IT WOULD BE BENEFICIAL TO ALL PARTIES INVOLVED; AND

PARAGRAPH 3: WHEREAS, COMMUNICATING PROPER CARE FOR PETS AS AN APPLICATION OF THE OFFICE OF THE DEAN OF STUDENTS' "TIGER TENETS" WOULD FURTHER EDUCATE THOSE PLANNING TO BRING THEIR PETS TAILGATING; AND

PARAGRAPH 4: WHEREAS, THE DEPARTMENT OF ATHLETICS HAS THE ABILITY TO WORK IN PARTNERSHIP WITH LSU POLICE TO COMMUNICATE THE NEED FOR PROPER PET CARE NOT ONLY WITHIN THE STUDENT POPULATION, BUT ALSO THROUGHOUT THE GAME DAY COMMUNITY; AND

PARAGRAPH 5: WHEREAS, A COMBINATION OF EFFORTS ON THE PART OF THE THREE AFOREMENTIONED DEPARTMENTS WOULD UNDOUBTEDLY LEAD TO A BETTER GAME DAY FOR PET OWNERS AND LSU'S FURRY FANS.

PARAGRAPH 6: THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT WE URGE AND REQUEST THE OFFICE OF THE DEAN OF STUDENTS, DEPARTMENT OF ATHLETICS, AND LSU POLICE DEPARTMENT TO COMMUNICATE AND ENFORCE PROPER CARE FOR PETS DURING TAILGATING AND OTHER EVENTS, AND

PARAGRAPH 7: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO DR. MARI FUENTES-MARTIN, DEAN OF STUDENTS; LAWRENCE RABALAIS, CHIEF OF POLICE; AND DAVID TAYLOR, ASSISTANT ATHLETIC DIRECTOR OF GAME/EVENT MANAGEMENT.

PARAGRAPH 8: THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
