A FINANCE BILL

TO ALLOCATE A MAXIMUM OF ONE THOUSAND NINE HUNDRED NINETY-FIVE DOLLARS AND ZERO CENTS (\$1,995.00) FROM THE STUDENT SENATE INITIATIVES ACCOUNT TO FUND THE PARKING FORGIVENESS INITIATIVE

PARAGRAPH 1: WHEREAS, MANY STUDENTS RECEIVE AT LEAST ONE PARKING TICKET DURING THEIR COLLEGE EXPERIENCE; AND

PARAGRAPH 2: WHEREAS THIS WOULD BE A SHOW OF GOODWILL TO THE STUDENTS FROM STUDENT GOVERNMENT; AND

PARAGRAPH 3: WHEREAS, A PROGRAM NEARLY IDENTICAL TO THIS INITIATIVE WAS IMPLEMENTED AND DEEMED A SUCCESS AT THE UNIVERSITY OF TEXAS; AND

PARAGRAPH 4: WHEREAS, THE GOAL OF THE PARKING FORGIVENESS PROGRAM IS TO EASE THE FINANCIAL CONSTRAINT ON STUDENTS, TO CONNECT TYPICALLY INCOMING STUDENTS WITH STUDENT GOVERNMENT, AND TO REDUCE FRUSTRATION WITH PARKING APPEALS BOARD AND THE LSU PARKING OFFICE; AND

PARAGRAPH 5: WHEREAS, THIS INITIATIVE HOPES TO ENCOURAGE POSITIVE PARKING HABITS ON CAMPUS; AND

PARAGRAPH 6: WHEREAS, THE FUNDS SHALL BE ALLOCATED AS FOLLOWS:

1: PARKING FORGIVENESS FUND (\$1995.00).

PARAGRAPH 7: THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT A MAXIMUM OF ONE THOUSAND NINE HUNDRED NINETY-FIVE DOLLARS ZERO CENTS WILL BE ALLOCATED FROM THE SENATE INITIATIVES ACCOUNT FOR THE PARKING FORGIVENESS INITIATIVE, AND

PARAGRAPH 8: BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO ALISA JONES,

STUDENT GOVERNMENT FINANCIAL COORDINATOR; AND
JEFF CAMPBELL, SENIOR DIRECTOR OF PARKING AND
TRANSPORTATION SERVICES; AND

PARAGRAPH 9: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
