**A BILL**  
**TO AMEND THE STUDENT GOVERNMENT BYLAWS**

**PARAGRAPH 1:** WHEREAS, THE STUDENT GOVERNMENT INITIATIVES ACCOUNT CURRENTLY HAS NO DEADLINE IN TERMS OF USING ALLOCATED FUNDS; AND

**PARAGRAPH 2:** WHEREAS, TRADITIONALLY, THE PEOPLE BEING FUNDED THROUGH THIS ACCOUNT HAVE HAD ONE YEAR TO USE THE FUNDS ALLOCATED TO THEM; AND

**PARAGRAPH 3:** WHEREAS, THIS ACCOUNT NEEDS A RESTRICTION ON TIME TO USE ALLOCATED FUNDS DUE TO ITS NATURE OF CROSSING OVER FROM ONE FISCAL YEAR TO THE NEXT; AND

**PARAGRAPH 4:** WHEREAS, ARTICLE XI, SECTION 2, SUBSECTION A SHALL BE AMENDED TO READ:

3. NO MONEY SHALL BE ALLOCATED FROM THIS FOR STUDENT TRAVEL.

4. FUNDS ALLOCATED FROM THIS ACCOUNT ARE LIMITED TO BE USED WITHIN THE FISCAL YEAR THEY ARE REQUESTED.

**PARAGRAPH 5:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT THE STUDENT GOVERNMENT BYLAWS BE AMENDED, AND

**PARAGRAPH 6:** BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO Ms. ALISA JONES, STUDENT GOVERNMENT FINANCIAL COORDINATOR.

**PARAGRAPH 7:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS ( $2/3$ ) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT

AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE
