**PARAGRAPH 1:** WHEREAS, HAVING A LIAISON WILL IMPROVE  
COMMUNICATION BETWEEN THE STAFF SENATE AND  
STUDENT SENATE; AND

**PARAGRAPH 2:** WHEREAS, THE APPOINTMENT OF ANAND  
RAMACHANDRAN PROVES THE COMMITMENT OF STAFF  
SENATE TO STAYING INVOLVED IN STUDENT AFFAIRS; AND

**PARAGRAPH 3:** WHEREAS, STUDENT SENATORS APPRECIATE THE

PROVIDING WITH THE APPOINTMENT OF THIS LIAISON;

**PARAGRAPH 4:** THEREFORE, BE IT RESOLVED BY THE

LSU STUDENT SENATE AND SIGNATURE BY THE  
PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL  
ACTION, OR IF VETOED BY THE PRESIDENT AND  
SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE  
OF SUCH APPROVAL
