A BILL

**TO AMEND THE STUDENT GOVERNMENT BYLAWS REGARDING ATTENDANCE
REQUIREMENTS FOR SENATORS REPRESENTING THE PAUL M. HEBERT LAW
CENTER**

PARAGRAPH 1: WHEREAS, ARTICLE III, SECTION 6 OF THE STUDENT GOVERNMENT BYLAWS COVERS THE REMOVAL OF SENATORS FOR EXCESSIVE ABSENCES OR LACK OF STUDENT OUTREACH POINTS; AND

PARAGRAPH 2: WHEREAS, SECTION 6.F. EXEMPTS SENATORS REPRESENTING THE GRADUATE SCHOOL AND THE SCHOOL OF VETERINARY MEDICINE FROM THESE REQUIREMENTS, DIRECTING THEM TO “MEET WITH THE SPEAKER TO DETERMINE APPROPRIATE REQUIREMENTS FOR THE SEMESTER BASED ON THEIR ACADEMIC DEMAND” AND HAVE THESE REQUIREMENTS APPROVED BY THE STUDENT GOVERNMENT ADVISOR; AND

PARAGRAPH 3: WHEREAS, THIS CLAUSE WAS ADDED PRIOR TO THE REUNION OF THE PAUL M. HEBERT LAW CENTER WITH THE MAIN CAMPUS OF LSU; AND

PARAGRAPH 4: WHEREAS, GIVEN THE KNOWN ACADEMIC BURDEN OF LEGAL STUDIES, ADDING THE LAW CENTER TO THE LIST OF DELEGATIONS COVERED BY THIS CLAUSE WOULD AID IN RECRUITING AND RETAINING SENATE REPRESENTATION FOR THE LAW CENTER;

PARAGRAPH 5: THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT ARTICLE III, SECTION 6.F. OF THE STUDENT GOVERNMENT BYLAWS BE AMENDED AS FOLLOWS:

“THESE REQUIREMENTS DO NOT APPLY TO SENATORS REPRESENTING ~~THE GRADUATE SCHOOL OR VET SCHOOL.~~ **THE GRADUATE SCHOOL, THE SCHOOL OF VETERINARY MEDICINE, OR THE HEBERT LAW CENTER.** EACH INDIVIDUAL SENATOR REPRESENTING ~~THE GRADUATE SCHOOL OR VET SCHOOL~~ **THESE SCHOOLS** MUST MEET WITH THE SPEAKER TO DETERMINE APPROPRIATE REQUIREMENTS FOR THE SEMESTER BASED ON THEIR ACADEMIC DEMAND. THESE REQUIREMENTS MUST BE APPROVED BY THE STUDENT GOVERNMENT ADVISOR.”

PARAGRAPH 6: BE IT RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO SARA KUEBEL, STUDENT BAR ASSOCIATION PRESIDENT, MICHELLE LOWERY, STUDENT GOVERNMENT ADVISOR, AND JASON BADEAUX, STUDENT BODY PRESIDENT.

PARAGRAPH 7: THIS BILL SHALL TAKE EFFECT, RETROACTIVE TO THE CALL TO ORDER OF THE FALL 2017 REGULAR SESSION, UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
