A RESOLUTION

CONVEYING BEST WISHES TO REP. STEVE SCALISE ON HIS RECOVERY

PARAGRAPH 1: WHEREAS, ON JUNE 14, 2017, REP. STEVE SCALISE, MAJORITY WHIP OF THE UNITED STATES HOUSE OF REPRESENTATIVES AND CONGRESSMAN FOR THE FIRST DISTRICT OF LOUISIANA, WAS SERIOUSLY WOUNDED BY GUNFIRE DURING A PRACTICE FOR THE ANNUAL CONGRESSIONAL BASEBALL GAME; AND

PARAGRAPH 2: WHEREAS, DESPITE THE SEVERITY OF HIS INJURIES, WHICH NECESSITATED MULTIPLE OPERATIONS AND SIX WEEKS OF HOSPITALIZATION, REP. SCALISE IS EXPECTED TO MAKE A FULL RECOVERY AND IS CURRENTLY UNDERGOING REHABILITATION; AND

PARAGRAPH 3: WHEREAS, REP. SCALISE IS AN ALUMNUS OF LSU (BS COMPUTER SCIENCE, 1989) WHO IS NOTED FOR HIS CONTINUED LOYALTY TO THE UNIVERSITY, AND

PARAGRAPH 4: WHEREAS, MANY ASSOCIATED WITH LSU EXPRESSED THEIR SUPPORT FOR REP. SCALISE IN THE WAKE OF THE SHOOTING, AND, NOW THAT IT HAS RECONVENED, IT IS FITTING AND PROPER FOR THE STUDENT SENATE THAT TWICE ELECTED HIM ITS SPEAKER TO DO SO AS WELL;

PARAGRAPH 5: THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT THIS BODY, IN THE NAME OF THE STUDENTS IT REPRESENTS, CONVEYS ITS BEST WISHES AND CONTINUED HOPES FOR REP. SCALISE'S RECOVERY, AND

PARAGRAPH 6: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO REP. STEVE SCALISE, MAJORITY WHIP OF THE UNITED STATES HOUSE OF REPRESENTATIVES AND CONGRESSMAN FOR THE FIRST DISTRICT OF LOUISIANA.

PARAGRAPH 7: THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
