**A RESOLUTION**

**URGING THE STUDENT CODE OF CONDUCT REVIEW COMMITTEE TO APPROVE THE EMERGENCY RESPONSE AMNESTY POLICY**

- PARAGRAPH 1:** WHEREAS, THE UNIVERSITY'S MAIN OBJECTIVE IS AND SHOULD ALWAYS BE STUDENT SAFETY; AND
- PARAGRAPH 2:** WHEREAS, THE PROPOSED POLICY WOULD ALLOW FOR AMNESTY DEFINED IN THE PROPOSAL AS "IMMUNITY TO THE STUDENT, STUDENT RESPONDER, OR ORGANIZATION FOR VIOLATIONS OF THE CODE OF STUDENT CONDUCT CONCERNING THE CONSUMPTION AND POSSESSION OF ALCOHOL OR DRUGS"; AND
- PARAGRAPH 3:** WHEREAS, THIS POLICY WOULD PROMOTE SAFETY BY ALLOWING STUDENTS TO REPORT HEALTH EMERGENCIES WITHOUT FEAR OF PERSONAL REPERCUSSIONS; AND
- PARAGRAPH 4:** WHEREAS, SIMILAR POLICIES HAVE BEEN IMPLEMENTED AT PEER INSTITUTIONS SUCH AS: THE UNIVERSITY OF ARKANSAS, CLEMSON UNIVERSITY, THE UNIVERSITY OF FLORIDA, THE UNIVERSITY OF ALABAMA, THE UNIVERSITY OF CENTRAL FLORIDA, THE UNIVERSITY OF LOUISVILLE, THE UNIVERSITY OF TEXAS- SAN ANTONIO, AND FLORIDA STATE UNIVERSITY; AND
- PARAGRAPH 5:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT THE STUDENT SENATE STANDS IN FULL SUPPORT OF THE PROPOSED EMERGENCY RESPONSE AMNESTY POLICY, AND
- PARAGRAPH 6:** BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO THE LSU DEAN OF STUDENTS, MARI FUENTES-MARTIN, PhD; THE DIRECTOR OF STUDENT ADVOCACY AND ACCOUNTABILITY, JONATHON SANDERS, PhD; AND THE STUDENT CODE OF CONDUCT REVIEW COMMITTEE.
- PARAGRAPH 7:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
