**A RESOLUTION**

**TO URGE AND REQUEST THE OFFICE OF ACADEMIC AFFAIRS TO STANDARDIZE ALL ACADEMIC COLLEGES IN GIVING MORE OPPORTUNITIES THAN SOLELY THE SUMMER SEMESTER IN COMPLETING A COURSE REQUIRED FOR GRADUATION.**

**PARAGRAPH 1:** WHEREAS, CERTAIN COURSES ARE REQUIRED TO GRADUATE IN A SPECIFIC DEGREE PROGRAM; AND

**PARAGRAPH 2:** WHEREAS, SOME OF THOSE REQUIRED CLASSES ARE ONLY OFFERED DURING THE SUMMER SEMESTER; AND

**PARAGRAPH 3:** WHEREAS, THE FALL AND SPRING SEMESTERS ARE MOSTLY STANDARD FOR STUDENTS; AND

**PARAGRAPH 4:** WHEREAS, THE SUMMER SEMESTER MAY NOT BE FEASIBLE FOR SOME STUDENTS DUE TO INTERNSHIPS, FINANCIAL STANDING, ETCETERA; AND

**PARAGRAPH 5:** WHEREAS, THERE HAVE BEEN INSTANCES OF REQUIRED CLASSES ONLY OFFERED DURING THE SPRING IN THE COLLEGES OF ART AND DESIGN AND SCIENCE; AND

**PARAGRAPH 6:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT REQUIRED COURSES BE OFFERED AT LEAST DURING EITHER THE FALL OR SPRING SEMESTERS, AND

**PARAGRAPH 7:** BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO DOCTOR MATTHEW LEE, DEAN OF ACADEMIC AFFAIRS, AND THE OFFICE OF THE UNIVERSITY REGISTRAR.

**PARAGRAPH 8:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
