A RESOLUTION

TO URGE AND REQUEST INFORMATION TECHNOLOGY SERVICES AND BARNES & NOBLE AT LSU TO BETTER PROMOTE THE ONLINE FEATURE WHICH ALLOWS STUDENTS TO VIEW THE REQUIRED AND RECOMMENDED TEXTS FOR A COURSE AS WELL AS MAKING IT EASILY ACCESSIBLE TO STUDENTS BY ADDING A LINK TO THE myLSU WEBSITE HOMEPAGE

PARAGRAPH 1: WHEREAS, THE LSU BARNES & NOBLE PROVIDES A FEATURE THAT ALLOWS STUDENTS TO FIND THE REQUIRED AND RECOMMENDED TEXTS FOR LSU COURSES; AND

PARAGRAPH 2: WHEREAS, THE FEATURE IS CURRENTLY AVAILABLE TO STUDENTS THROUGH THE SCHEDULE REQUEST SERVICE; AND

PARAGRAPH 3: WHEREAS, THIS INITIATIVE SEEKS TO PROMOTE THIS FEATURE AS A GENERAL FINANCIAL SERVICE FOR STUDENTS TO CALCULATE TEXTBOOK PRICES AND LOCATE ISBN NUMBERS FOR CURRENT COURSES; AND

PARAGRAPH 4: THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT THE LSU BARNES & NOBLE TEXTBOOK FEATURE IS PROMOTED THROUGH myLSU AND ADDED AS A LINK ON THE myLSU WEBSITE HOMEPAGE, AND

PARAGRAPH 5: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO IT COMMUNICATIONS AND PLANNING OFFICER SHERI THOMPSON, LSU BOOKSTORE TEXTBOOK MANAGER WHIT GREEN, AND ASSOCIATE DIRECTOR MICHELLE LOWERY.

PARAGRAPH 6: THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
