A RESOLUTION

TO URGE AND REQUEST THE ADMISSIONS, STANDARDS, AND HONORS COMMITTEE OF THE FACULTY SENATE TO CHANGE THE MINIMUM CREDIT HOUR REQUIREMENT FOR PRESIDENT'S HONOR ROLL AND THE DEAN'S LIST FROM 15 HOURS TO 12 HOURS FOR THE FALL AND SPRING SEMESTERS AND FROM 15 HOURS TO 9 HOURS FOR THE SUMMER TERM.

PARAGRAPH 1: WHEREAS, UNDERGRADUATE STUDENTS ENROLLED IN AT LEAST 15 CREDIT HOURS WHO EARN GRADE-POINT AVERAGES OF 4.0 AND ABOVE DURING ANY SEMESTERS ARE LISTED ON THE PRESIDENT'S HONOR ROLL; AND

PARAGRAPH 2: WHEREAS, UNDERGRADUATE STUDENTS ENROLLED IN AT LEAST 15 CREDIT HOURS WHO EARNED GRADE POINT AVERAGES OF 3.5 TO 3.9 DURING ANY SEMESTERS ARE LISTED ON THE DEAN'S LIST; AND

PARAGRAPH 3: WHEREAS, 11 OUT OF 14 OF LSU'S PEER UNIVERSITIES, INCLUDING VIRGINIA TECH, PURDUE, ARKANSAS, AND MISSISSIPPI STATE, HAVE A MINIMUM HOUR REQUIREMENT OF 12 CREDIT HOURS IN ORDER TO BE PLACED ON ANY TYPE OF HONOR ROLL; AND

PARAGRAPH 4: WHEREAS, FOR UNDERGRADUATE STUDENTS, FULL-TIME ENROLLMENT IS CONSIDERED TO BE 12 CREDIT HOURS FOR THE SPRING AND FALL SEMESTERS AND 6 CREDIT HOURS FOR THE SUMMER TERM.

PARAGRAPH 5: THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT LSU CHANGE ITS 15 HOUR CREDIT REQUIREMENT FOR THE PRESIDENT'S HONOR ROLL AND THE DEAN'S LIST TO 12 HOURS FOR THE SPRING AND FALL SEMESTERS AND 9 HOURS FOR THE SUMMER TERM, AND

PARAGRAPH 6: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO THE ADMISSIONS, STANDARDS, VICE PROVOST FOR ACADEMIC PROGRAMS AND SUPPORT SERVICES MATT LEE, FACULTY SENATE PRESIDENT KEN MCMILLIAN, SENIOR VICE PROVOST FOR HUMAN RESOURCES AND ACADEMIC SPACE MANAGEMENT JANE CASSIDY, AND STUDENT BODY PRESIDENT JASON BADEAUX.

PARAGRAPH 7: THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
