**A FINANCE BILL**

**TO ALLOCATE EIGHTY-FIVE DOLLARS AND ZERO CENTS (\$85.00) FROM THE  
LEGISLATIVE INITIATIVES ACCOUNT TO FUND ONE (1) MICROWAVE FOR  
MIDDLETON LIBRARY**

**PARAGRAPH 1:** WHEREAS, ONE OF THE MIDDLETON LIBRARY MICROWAVES IS UNAVAILABLE FOR USE DUE TO BEING BROKEN; AND

**PARAGRAPH 2:** WHEREAS, STUDENTS HAVE VOICED THEIR WANT FOR AN ADDITIONAL MICROWAVE; AND

**PARAGRAPH 3:** WHEREAS, THERE IS A NEED TO HAVE WARM FOOD AND DRINKS AFTER CC'S CLOSES; AND

**PARAGRAPH 4:** WHEREAS, THE FUNDS SHOULD BE ALLOCATED AS FOLLOWS:

- 1. OSTER OGH6901 0.9 CUBIC FEET 900-WATT COUNTERTOP DIGITAL MICROWAVE OVEN, STAINLESS STEEL/BLACK - \$85 X 1**  
**A. TOTAL = \$85.00.**

**PARAGRAPH 5:** THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT A MAXIMUM OF EIGHTY-FIVE DOLLARS AND ZERO CENTS (\$85.00) BE ALLOCATED FROM THE LEGISLATIVE INITIATIVES ACCOUNT TO FUND ONE (1) MICROWAVE UNIT FOR MIDDLETON LIBRARY, AND

**PARAGRAPH 6:** BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO MS. CORTNEY GREAVIS, STUDENT GOVERNMENT FINANCIAL COORDINATOR; AND MARK FORSTALL, AUXILIARY SERVICES FACILITIES MANAGER.

**PARAGRAPH 7:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS ( $\frac{2}{3}$ ) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
