**A RESOLUTION**

**A RESOLUTION TO URGE AND REQUEST THE OFFICE OF AUXILIARY SERVICES  
AND THE TIGER CARD OFFICE TO IMPLEMENT CHANGES REGARDING  
PREFERRED NAMES ON LSU IDENTIFICATION CARDS**

- PARAGRAPH 1:** WHEREAS, LSU TIGER CARD OFFICE REQUIRES STUDENTS AND EMPLOYEES TO HAVE THEIR LEGAL NAME AS STATED ON OTHER FORMS OF IDENTIFICATION AS THEIR NAME ON TIGER CARDS; AND
- PARAGRAPH 2:** WHEREAS, LGBTQIA+ STUDENTS WHO HAVE DIFFERENT NAMES RATHER THAN THAT OF THEIR BIRTH NAMES ARE INCORRECTLY IDENTIFIED ON THEIR IDENTIFICATION CARD; AND
- PARAGRAPH 3:** WHEREAS, UNDERGRADUATE INTERNATIONAL STUDENTS WHO ARE RECOGNIZED BY A PREFERRED NAME RATHER THAN THEIR BIRTH NAME ARE NOT ALLOWED TO CHANGE THEIR NAME ON THEIR IDENTIFICATION CARD; AND
- PARAGRAPH 4:** WHEREAS, 192 OUT OF THE 336 PERSONS WHO PARTICIPATED IN A STUDY RECOGNIZED THAT THEY HAVE A PREFERRED NAME THAT IS NOT ON THEIR LSU TIGER CARD; AND
- PARAGRAPH 5:** WHEREAS, SCHOOLS SUCH AS UNIVERSITY OF CALIFORNIA- LOS ANGELES, UNIVERSITY OF TEXAS AT AUSTIN, ALONG WITH 106 OTHER COLLEGES AND UNIVERSITIES ALLOW STUDENTS AND EMPLOYEES TO HAVE THEIR PREFERRED NAME ON IDENTIFICATION CARDS; AND
- PARAGRAPH 6:** WHEREAS, STUDENTS WHO HAVE A PREFERRED NAME WILL HAVE IT STATED ABOVE THEIR LEGAL NAME ON THEIR LSU IDENTIFICATION CARDS; AND
- PARAGRAPH 7:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT LSU CHANGE ITS LSU IDENTIFICATION CARD REQUIREMENTS FROM SAID PERSON'S LEGAL NAME TO PREFERRED NAME THAT THE STUDENT IDENTIFIES WITH, AND
- PARAGRAPH 8:** BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO

MARGOT CARROLL, ASSISTANT VICE PRESIDENT OF LSU  
AUXILIARY SERVICES.

**PARAGRAPH 9:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY  
A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE  
LSU STUDENT SENATE AND SIGNATURE BY THE  
PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL  
ACTION, OR IF VETOED BY THE PRESIDENT AND  
SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE  
OF SUCH APPROVAL.
