A RESOLUTION

TO URGE AND REQUEST THE OFFICE OF FACILITY SERVICES TO ADD FEMININE PRODUCT DISPOSAL BINS IN ALL APPROPRIATE BATHROOM STALLS ON CAMPUS, SPECIFICALLY IN OLDER BUILDINGS

PARAGRAPH 1: WHEREAS, MANY RESTROOM STALLS ON CAMPUS, SPECIFICALLY OLDER BUILDINGS, SUCH AS ALLEN AND HIMES HALLS, LACK THE PROPER DISPOSAL BINS FOR FEMININE PRODUCTS; AND

PARAGRAPH 2: WHEREAS, LSU SPECIFICALLY ASKS THAT STUDENTS DO NOT FLUSH THESE PRODUCTS, BUT FAIL TO PROVIDE APPROPRIATE DISPOSAL BINS WITHIN HANDS REACH; AND

PARAGRAPH 3: WHEREAS, THIS CREATES CLEANLINESS ISSUES IN RESTROOMS AROUND CAMPUS AND POSES AN UNNECESSARY BURDEN ON MENSTRUATING STUDENTS; AND

PARAGRAPH 4: THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT ALL NECESSARY RESTROOM STALLS ON THE UNIVERSITY CAMPUS BE FURNISHED WITH FEMININE PRODUCT DISPOSAL BINS, WHETHER IT BE TRASH CANS, WALL BOXES, OR, ANOTHER FORM, AND

PARAGRAPH 5: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO DAVE MAHARREY, EXECUTIVE DIRECTOR OF FACILITY SERVICES AND STACY WHITFIELD, ASSISTANT DIRECTOR OF BUILDING SERVICES.

PARAGRAPH 6: THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
