**A FINANCE BILL**

**TO ALLOCATE A MAXIMUM OF SEVEN HUNDRED FORTY DOLLARS AND EIGHTY-EIGHT CENTS (\$740.88) FROM THE STUDENT GOVERNMENT INITIATIVES ACCOUNT TO FUND THE SECURITY COSTS FOR THE STUDENT UNION'S EXTENDED HOURS DURING THE FALL 2017 FINAL EXAMINATION PERIOD**

- PARAGRAPH 1:** WHEREAS, SECURITY PREVISIONS WILL ENCOURAGE STUDENTS TO UTILIZE THIS SPACE THAT WAS HIGHLY SUCCESSFUL DURING THE FALL 2016 AND SPRING 2017 FINAL EXAMINATION PERIOD; AND
- PARAGRAPH 2:** WHEREAS, HAVING SECURITY IS CRUCIAL BECAUSE ALL OTHER FLOORS OF THE UNION MUST REMAIN CLOSED AND SECURE; AND
- PARAGRAPH 3:** WHEREAS, 2 LOFTON UNARMED SECURITY GUARDS WILL COST \$13.23/HOUR FOR FOUR-HOUR SHIFTS (11 P.M. TO 3 A.M.); AND
- PARAGRAPH 4:** WHEREAS, THE DONATIONS OF STUDY ESSENTIALS SUCH AS FOOD, BEVERAGES, AND SUPPLIES ENTICES STUDENTS TO UTILZE THE SPACE WHICH NECESSITATES THE HIRING OF TWO UNARMED LOFTON SECURITY OFFICERS TO ACCOUNT FOR THE INCREASE OF TRAFFIC THROUGH THE UNION; AND
- PARAGRAPH 5:** WHEREAS, STUDENTS REQUIRE ANOTHER VIABLE OPTION TO STUDY LATE AT NIGHT DURING THE MOST CROWDED STUDY PERIOD OF THE SEMESTER; AND
- PARAGRAPH 6:** WHEREAS, STUDENT GOVERNMENT WILL RECEIVE PUBLICITY FROM THE EVENT THROUGH ADVERTISEMENTS, STUDENT GOVERNMENT VOLUNTEERS WORKING THE EVENT, AND STUDENT GOVERNMENT GIVEAWAYS AT THE EVENT; AND
- PARAGRAPH 7:** THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT A MAXIMUM OF SEVEN HUNDRED FORTY DOLLARS AND EIGHTY-EIGHT CENTS (\$740.88) FROM THE STUDENT GOVERNMENT INITIATIVES ACCOUNT WILL FUND THE SECURITY COSTS FOR THE STUDENT UNION'S EXTENDED HOURS DURING THE FALL 2017 FINAL EXAMINATION PERIOD, AND

**PARAGRAPH 8:** BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO COURTNEY REEDER, STUDENT GOVERNMENT FINANCIAL COORDINATOR; AND EMILY JONES, STUDENT GOVERNMENT DIRECTOR OF STUDENT AUXILIARY SERVICES.

**PARAGRAPH 9:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
