A RESOLUTION

**TO URGE AND REQUEST THE OFFICE OF AUXILIARY SERVICES TO ADD A
PRINTER IN THE UNION FOR STUDENTS TO USE**

- PARAGRAPH 1:** WHEREAS, HUNDREDS OF STUDENTS USE THE LSU STUDENT UNION DAILY AS A SPACE FOR STUDYING AND MEETING; AND
- PARAGRAPH 2:** WHEREAS, THE LSU STUDENT UNION IS RESPONSIBLE FOR PROVIDING FACILITIES, SERVICES, AND CONVENIENCES FOR THE DIVERSE NEEDS AND ACTIVITIES OF THE CAMPUS COMMUNITY; AND
- PARAGRAPH 3:** WHEREAS, CURRENT PRINTING SERVICES IN THE UNION ARE ONLY OFFERED TO STUDENTS FROM 7:30AM-5:00PM ON WEEKDAYS AND 11:00 AM-3:00 PM ON SATURDAYS AT THE UPS STORE; AND
- PARAGRAPH 4:** WHEREAS, THE STANDARD LSU STUDENT UNION HOURS OF OPERATION ARE FROM 7:00 AM-11:00 PM ON WEEKDAYS, 8:00 AM-11:00 PM ON SATURDAYS AND 10:00 AM-11:00 PM ON SUNDAYS; AND
- PARAGRAPH 5:** WHEREAS, MANY STUDENTS ARE UNAWARE OF CURRENT PRINTING SERVICES OFFERED IN THE UNION BECAUSE OF INSUFFICIENT ADVERTISING AND SEQUESTERED LOCATION OF PRINTERS; AND
- PARAGRAPH 6:** WHEREAS, UNION PRINTING SERVICES WILL BE IDENTICAL TO THE PRINTING SERVICES PROVIDED BY MIDDLETON LIBRARY, WHERE TIGERCASH IS USED AS A METHOD; AND
- PARAGRAPH 7:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT A PRINTER BE ADDED IN THE UNION FOR STUDENTS TO USE DURING THE FULL UNION HOURS OF OPERATION, AND
- PARAGRAPH 8:** BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO MARGOT CARROLL, ASSISTANT VICE PRESIDENT OF AUXILIARY SERVICES
- PARAGRAPH 9:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
