A RESOLUTION

**TO URGE AND REQUEST THE COLLEGE OF BUSINESS TO EXPAND THE COURSE OFFERINGS FOR
FINANCE 1060**

- PARAGRAPH 1:** WHEREAS, THE E. J. OURSO COLLEGE OF BUSINESS CURRENTLY OFFERS A PERSONAL MONEY MANAGEMENT COURSE CALLED FINANCE 1060; AND
- PARAGRAPH 2:** WHEREAS, FINANCE 1060 IS ONLY OFFERED IN THE FALL SEMESTER AS A ONE HOUR CREDIT COURSE; AND
- PARAGRAPH 3:** WHEREAS, THIS CLASS TEACHES INTEGRAL LESSONS ABOUT PERSONAL FINANCE THAT CAN BE SEEN AS BENEFICIAL TO MOST COLLEGE STUDENTS; AND
- PARAGRAPH 4:** WHEREAS, WE URGE THE COLLEGE OF BUSINESS TO MAKE THIS CLASS MORE NOTEWORTHY BY INCREASING THE COURSE HOURS TO THREE AND OFFERING THIS COURSE DURING BOTH THE FALL AND SPRING SEMESTERS; AND
- PARAGRAPH 5:** WHEREAS, WE FEEL THAT THIS IS A GREAT CLASS FOR ANY STUDENT TO TAKE AS AN ELECTIVE; AND
- PARAGRAPH 6:** WHEREAS, THIS WOULD INCREASE GENERAL FINANCIAL KNOWLEDGE FOR STUDENTS UPON GRADUATION.
- PARAGRAPH 7:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT FINANCE 1060 BE CHANGED TO A THREE HOUR COURSE OFFERED IN BOTH THE FALL AND THE SPRING SEMESTERS; AND
- PARAGRAPH 8:** BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO MATT LEE, VICE PROVOST FOR ACADEMIC PROGRAMS AND SUPPORT SERVICES, TIMOTHY CHANDLER, ASSOCIATE DEAN FOR THE COLLEGE OF BUSINESS, AND RAJESH NARAYANAN, DEPARTMENT OF FINANCE CHAIR.
- PARAGRAPH 9:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
