9 **A RESOLUTION**

10 **TO URGE THE LOUISIANA STATE UNIVERSITY ADMINISTRATION, ATHLETIC**  
11 **DEPARTMENT, VETERINARY SCHOOL, AND ANY OTHER APPROPRIATE DEPARTMENTS,**  
12 **THAT, BEGINNING WITH THE PRESENT MASCOT MIKE VI, THAT ALL LSU TIGER**  
13 **MASCOTS, UPON THEIR DEATHS, BE BURIED OR ENTOMBED ON CAMPUS IN A SUITABLE**  
14 **MANNER, AT A LOCATION ACCESSIBLE TO THE PUBLIC**

16 **PARAGRAPH 1:** WHEREAS, LSU’S LIVE TIGER MASCOTS HAVE BEEN AN INTEGRAL  
17 PART OF THE UNIVERSITY’S TRADITION AND CULTURE SINCE  
18 1936, AS WELL AS AN INTEGRAL PART OF EVERY LSU STUDENT’S  
19 MEMORIES; AND,

21 **PARAGRAPH 2:** WHEREAS, LSU’S LIVE TIGER MASCOTS ARE THE VISIBLE SYMBOL  
22 TO THE WORLD OF EVERYTHING POSITIVE AND GOOD ABOUT  
23 LSU, WHILE LITERALLY GIVING THEIR LIVES FOR THE  
24 UNIVERSITY; AND,

26 **PARAGRAPH 3:** WHEREAS, OTHER SEC UNIVERSITIES SUCH AS THE UNIVERSITY  
27 OF GEORGIA AND TEXAS A&M HONOR THEIR DECEASED  
28 MASCOTS SIMILARLY, BURYING OR ENTOMBING THEM AT A PLACE  
29 OF HONOR NEAR THEIR FOOTBALL STADIUMS; AND,

31 **PARAGRAPH 4:** WHEREAS, ANY EXISTING REMAINS ABLE TO BE MOVED SHOULD  
32 BE INCLUDED IN THE NEW LOCATION.

34 **PARAGRAPH 5:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA  
35 STATE UNIVERSITY STUDENT SENATE THAT LSU  
36 ADMINISTRATION, THE ATHLETIC DEPARTMENT, THE  
37 VETERINARY SCHOOL, AND ANY OTHER APPROPRIATE  
38 DEPARTMENTS BE URGED THAT, BEGINNING WITH THE PRESENT  
39 MASCOT MIKE VI, THAT ALL LSU TIGER MASCOTS, UPON THEIR  
40 DEATHS, BE BURIED OR ENTOMBED ON CAMPUS IN A SUITABLE  
41 MANNER, AT A LOCATION ACCESSIBLE TO THE PUBLIC.

43 **PARAGRAPH 6:** BE IT FURTHER RESOLVED THAT A COPY OF THIS  
44 RESOLUTION BE TRANSMITTED TO LSU  
45 ADMINISTRATION, THE ATHLETIC DEPARTMENT, AND THE  
46 VETERINARY SCHOOL.

48 **PARAGRAPH 7:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A  
49 SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU  
50 STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON  
51 LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE  
52 PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON  
53 THE DATE OF SUCH APPROVAL.
