10 **TO URGE AND REQUEST THAT THE LOUISIANA STATE UNIVERSITY TIGER ATHLETIC**
11 **FOUNDATION CONSIDER DESIGNING ARTWORK TO ENHANCE THE EXTERIOR OF**
12 **SECTIONS 20 AND 21 OF TIGER STADIUM.**

14 **PARAGRAPH 1:** WHEREAS, THE EXTERIOR OF SECTIONS 20 AND 21 OF TIGER
15 STADIUM HAS BEEN IDENTIFIED AS A SURFACE AT LSU THAT
16 COULD BE REVITALIZED; AND

18 **PARAGRAPH 2:** WHEREAS, ARTWORK OR AN INSCRIPTION TO FILL THE SURFACE
19 WOULD NOT ONLY INCREASE THE VALUE OF TIGER STADIUM,
20 BUT WOULD ALSO STRENGTHEN MORALE AND LSU SPIRIT; AND

23 **PARAGRAPH 3:** WHEREAS, THE SURFACE WOULD EXPOSE LSU STUDENTS AND
24 LSU GUESTS TO ART EXPRESSION AND THE ARTS IN GENERAL.

26 **PARAGRAPH 4:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA
27 STATE UNIVERSITY STUDENT SENATE URGE AND
28 REQUEST THAT THE LSU TIGER ATHLETIC FOUNDATION
29 CONSIDER DESIGNING ARTWORK OR AN INSCRIPTION TO ENHANCE
30 THE EXTERIOR OF SECTIONS 20 AND 21 OF TIGER STADIUM, AND

32 **PARAGRAPH 5:** BE IT FURTHER RESOLVED THAT A COPY OF THIS
33 RESOLUTION BE TRANSMITTED TO PRESIDENT AND
34 CHIEF EXECUTIVE OFFICER RICK PERRY, VICE PRESIDENT AND
35 CHIEF FINANCIAL OFFICER FRANK MILLER, DIRECTOR OF
36 STADIUM CLUB SOUTH KIMBERLY LUDWIG, SENIOR ASSOCIATE
37 ATHLETIC DIRECTOR TIGER ATHLETIC FOUNDATION LIAISON
38 FOR CONSTRUCTION EDDIE NUNEZ AND TIGER ATHLETIC
39 FOUNDATION PROJECT MANAGER EMMETT E. DAVID OF THE
40 LSU TIGER ATHLETIC FOUNDATION.

43 SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU
44 STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON
45 LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE
46 PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON
47 THE DATE OF SUCH APPROVAL.
