16 **PARAGRAPH 1:** WHEREAS, DURING VARIOUS SPORTING EVENTS, SPECTATORS
17 WITH TAF PARKING PASSES PARK THEIR VEHICLES IN RESERVED
18 SPOTS IN THE TENNIS COURT LOT (LOT 206) BEHIND THE PETE
19 MARAVICH ASSEMBLY CENTER; AND

21 **PARAGRAPH 2:** WHEREAS, STUDENTS ARE MADE TO VACATE THE LOT
22 COMPLETELY, INCONVENIENTLY DISPLACING THE 115 RESIDENTS
23 WHO PARK THERE; AND

25 **PARAGRAPH 3:** WHEREAS, FULL-TIME RESIDENT STUDENTS SHOULD BE THE
26 MAIN CONCERN OF THE UNIVERSITY; AND

28 **PARAGRAPH 4:** WHEREAS, OTHER POSSIBLE LOCATIONS FOR SPECTATORS TO
29 PARK SHOULD BE EXPLORED SO AS NOT TO CONCERN STUDENTS
30 ABOUT BEING TICKETED AND/OR TOWED FROM A RESIDENT
31 PARKING SPOT.

37 GAMEDAY PARKING OPTIONS FOR SPECTATORS WITHOUT

41 **PARAGRAPH 6:** BE IT FURTHER RESOLVED THAT A COPY OF THIS
42 RESOLUTION BE TRANSMITTED TO THE OFFICE OF

44 FOUNDATION, AND THE DEPARTMENT OF RESIDENTIAL LIFE.

47 MAJORITY (ONE HALF PLUS ONE) VOTE OF THE LSU STUDENT
48 SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF
49 TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE
50 PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON
51 THE DATE OF SUCH APPROVAL.
