13 **PARAGRAPH 1:** WHEREAS, DR. KURPIUS ARRIVED AT LSU IN AUGUST OF 1997 AS  
14 AN ASSISTANT PROFESSOR IN THE MANSHIP SCHOOL OF MASS  
15 COMMUNICATION; AND

17 **PARAGRAPH 2:** WHEREAS, IN 2003 AFTER EARNING AN ASSOCIATE  
18 PROFESSORSHIP, DR. KURPIUS ASSUMED THE ROLE OF INTERIM  
19 DIRECTOR OF STUDENT MEDIA; AND

21 **PARAGRAPH 3:** WHEREAS, IN 2005 DR. KURPIUS ASSUMED THE ROLE OF  
22 ASSOCIATE DEAN OF UNDERGRADUATE STUDIES &  
23 ADMINISTRATION FOR THE MANSHIP SCHOOL OF MASS  
24 COMMUNICATION; AND

26 **PARAGRAPH 4:** WHEREAS, IN 2011, DR. KURPIUS WAS PROMOTED TO HIS  
27 CURRENT POSITION OF ASSOCIATE VICE CHANCELLOR OF  
28 ENROLLMENT MANAGEMENT; AND

30 **PARAGRAPH 5:** WHEREAS, DR. KURPIUS SERVED AS AN ASSOCIATE PROFESSOR  
31 WHILE HOLDING HIS POSITION AS ASSOCIATE VICE CHANCELLOR  
32 OF ENROLLMENT MANAGEMENT AND EVENTUALLY BECAME A  
33 FULL PROFESSOR; AND

35 **PARAGRAPH 6:** WHEREAS, HE ESTABLISHED LSU'S FIRST STRATEGIC  
36 ENROLLMENT MANAGEMENT PLAN; AND

38 **PARAGRAPH 7:** WHEREAS, HE HAS MANAGED OVER \$300 MILLION IN  
39 SCHOLARSHIPS AND FINANCIAL AID IN ADDITION TO RECRUITING  
40 AND ENROLLING NEARLY EVERY STUDENT CURRENTLY ENROLLED  
41 AT LSU; AND
