9 **TO PLACE A REFERENDUM BEFORE THE LOUISIANA STATE UNIVERSITY STUDENT**  
10 **BODY IN THE FALL 2014 ELECTION TO AMEND THE LSU STUDENT GOVERNMENT**  
11 **CONSTITUTION.**

14 **PARAGRAPH 1:** WHEREAS, SGB No. 4, A BILL TO AMEND ARTICLE 1 OF THE  
15 CONSTITUTION OF THE LOUISIANA STATE UNIVERSITY STUDENT  
16 GOVERNMENT TO INCLUDE AN EQUAL OPPORTUNITY CLAUSE,  
17 PASSED WITH 100 PERCENT IN FAVOR; AND

19 **PARAGRAPH 2:** WHEREAS, THESE CHANGES MUST NOW BE APPROVED BY THE  
20 STUDENT BODY IN THE FALL 2014 ELECTION BY THE MAJORITY  
21 OF THE STUDENTS VOTING.

24 **PARAGRAPH 3:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA  
25 STATE UNIVERSITY STUDENT SENATE THAT THERE  
26 BE A REFERENDUM SUBMITTED TO THE ELECTORS  
27 OF THE UNIVERSITY AND FURTHER AUTHORIZES  
28 THE FOLLOWING PROPOSITION BE PLACED ON THE  
29 FALL 2014 STUDENT GOVERNMENT ELECTION  
30 BALLOT:

31 “TO APPROVE A CHANGE TO THE STUDENT GOVERNMENT  
32 CONSTITUTION TO ADD AN EQUAL OPPORTUNITY CLAUSE,  
33 OFFICIALLY ESTABLISHING THAT LOUISIANA STATE UNIVERSITY  
34 STUDENT GOVERNMENT AIMS TO REPRESENT ALL STUDENTS  
35 EQUALLY.

39 **PARAGRAPH 4:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A TWO  
40 THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND  
41 SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR  
42 PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND  
43 SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF  
44 SUCH APPROVAL.
