9 **TO PLACE A REFERENDUM BEFORE THE LOUISIANA STATE UNIVERSITY STUDENT**  
10 **BODY IN THE FALL 2014 ELECTION TO AMEND THE LSU STUDENT GOVERNMENT**  
11 **CONSTITUTION.**

14 **PARAGRAPH 1:** WHEREAS, SGB No. 5, A BILL TO ADJUST THE APPORTIONMENT  
15 PROCEDURE OF THE STUDENT SENATE AS REFLECTED IN THE  
16 STUDENT GOVERNMENT CONSTITUTION, WAS APPROVED AND  
17 PASSED BY THE STUDENT BODY SENATE WITH 92 PERCENT IN  
18 FAVOR; AND

20 **PARAGRAPH 2:** WHEREAS, THESE CHANGES MUST NOW BE APPROVED BY THE  
21 STUDENT BODY IN THE FALL 2014 ELECTION BY THE MAJORITY  
22 OF THE STUDENTS VOTING.

24 **PARAGRAPH 3:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA  
25 STATE UNIVERSITY COLLEGE STUDENT SENATE  
26 THAT THERE BE A REFERENDUM SUBMITTED TO  
27 THE ELECTORS OF THE UNIVERSITY AND FURTHER  
28 AUTHORIZES THE FOLLOWING PROPOSITION BE  
29 PLACED ON THE FALL 2014 STUDENT GOVERNMENT  
30 ELECTION BALLOT:

31 “TO APPROVE A CHANGE TO THE STUDENT GOVERNMENT  
32 CONSTITUTION THAT WOULD ADJUST THE APPORTIONMENT  
33 PROCEDURE OF THE STUDENT SENATE ALLOWING FOR A MORE  
34 ACCURATE REFLECTION OF THE MAKEUP OF THE STUDENT BODY  
35 AND MORE STUDENT REPRESENTATION IN THE SENATE.

40 **PARAGRAPH 4:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A TWO-  
41 THIRDS MAJORITY (2/3) VOTE OF THE LSU STUDENT SENATE  
42 AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR  
43 PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND  
44 SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF  
45 SUCH APPROVAL.
