9 **A FINANCE BILL**

10 **TO ALLOCATE A MAXIMUM OF TEN THOUSAND DOLLARS AND ZERO CENTS**  
11 **(\$10,000.00) FROM THE STUDENT GOVERNMENT SURPLUS ACCOUNT TO FUND THE**  
12 **STUDENT GOVERNMENT REBRANDING EFFORT.**

14 **PARAGRAPH 1:** WHEREAS, THE LOUISIANA STATE UNIVERSITY (LSU) STUDENT  
15 GOVERNMENT HAS GONE THROUGH A RIGOROUS PROCESS TO  
16 CREATE A NEW IMAGE OF STUDENT GOVERNMENT IN THE MIND  
17 OF STUDENTS, AND;

19 **PARAGRAPH 2:** WHEREAS, THIS REBRANDING EFFORT IS TYPIFIED BY A NEW  
20 LOGO WHICH SHOULD BE DISPLAYED ON ALL PROJECTS FUNDED  
21 AND CREATED BY STUDENT GOVERNMENT TO BETTER DISPLAY  
22 STUDENT GOVERNMENT EFFORTS TO IMPROVE LSU'S CAMPUS  
23 AND THE EVERYDAY COLLEGE EXPERIENCE OF LSU STUDENTS,

26 **PARAGRAPH 3:** WHEREAS, THE ITEMS PURCHASED USING THESE FUNDS SHALL BE  
27 LEFT TO THE DISCRETION OF THE PRESIDENT, SPEAKER OF THE  
28 SENATE AND CHIEF JUSTICE OF STUDENT GOVERNMENT;

30 **PARAGRAPH 4:** THEREFORE, BE IT ENACTED BY THE LOUISIANA  
31 STATE UNIVERSITY AND AGRICULTURAL AND  
32 MECHANICAL COLLEGE STUDENT SENATE THAT A  
33 MAXIMUM OF TEN THOUSAND DOLLARS AND ZERO CENTS  
34 (\$10,000.00) FROM THE STUDENT GOVERNMENT SURPLUS  
35 ACCOUNT WILL BE ALLOCATED TO FUND THE STUDENT  
36 GOVERNMENT REBRANDING EFFORT, AND

38 **PARAGRAPH 5:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS  
39 (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY  
40 THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL  
41 ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY  
42 APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
