10 **TO ALLOCATE TWENTY-FOUR THOUSAND ONE HUNDRED EIGHTY DOLLARS AND SIXTY**
11 **CENTS (\$24,180.60) FROM THE LSU STUDENT GOVERNMENT SURPLUS ACCOUNT TO**
12 **FUND THE PURCHASE OF PICNIC TABLES FOR THE LSU MEMORIAL OAK GROVE**

14 **PARAGRAPH 1:** WHEREAS, THE MEMORIAL OAK GROVE IS HOME TO 30 LIVE OAK
15 TREES, WHICH ARE DEDICATED TO FALLEN SOLDIERS WHO GAVE
16 THEIR LIVES IN SERVICE TO THE UNITED STATES OF AMERICA;
17 AND

19 **PARAGRAPH 2:** WHEREAS, THE MEMORIAL OAK GROVE IS LOCATED JUST SOUTH
20 OF THE LSU STUDENT UNION; AND

22 **PARAGRAPH 3:** WHEREAS, THERE IS CURRENTLY A NEED FOR ADDITIONAL
23 SEATING OPTIONS WITHIN PROXIMITY OF THE LSU STUDENT
24 UNION; AND

26 **PARAGRAPH 4:** WHEREAS, THE MEMORIAL OAK GROVE IS A HIGH-TRAFFIC AREA
27 THAT IS UNDER-UTILIZED AND UNRECOGNIZED BY THE LSU
28 COMMUNITY; AND

30 **PARAGRAPH 5:** WHEREAS, THE ADDITION OF PICNIC TABLES INTO THIS AREA
31 WILL BE USED TO SATISFY THE DEMAND FOR AN INCREASE IN
32 SEATING IN PROXIMITY OF THE LSU STUDENT UNION; AND

34 **PARAGRAPH 6:** WHEREAS, LSU FACILITY SERVICES' DEPARTMENT OF
35 PLANNING, DESIGN, AND CONSTRUCTION, LSU AUXILIARY
36 SERVICES, AND THE LSU STUDENT UNION ADMINSTRATORS
37 HAVE PLANS TO REDESIGN THE MEMORIAL OAK GROVE AND
38 THESE PICNIC TABLES ARE VITAL TO THE COMPLETION OF THIS
39 PROJECT; AND

41 **PARAGRAPH 7:** WHEREAS, THIS EXPENDITURE WOULD COVER THE FOLLOWING
42 ACQUISITIONS:

49 STATE UNIVERSITY STUDENT SENATE THAT A MAXIMUM
50 OF TWENTY-FOUR THOUSAND ONE HUNDRED EIGHTY DOLLARS
51 AND SIXTY CENTS (\$24,180.60) BE ALLOCATED FROM THE
52 STUDENT GOVERNMENT SURPLUS ACCOUNT TO FUND THE
53 PURCHASE OF PICNIC TABLES FOR THE MEMORIAL OAK GROVE.
