23 **PARAGRAPH 3:** WHEREAS, DR. QUEEN FORMERLY SERVED AS THE CHAIR OF THE
24 DEPARTMENT OF MUSIC, THEATRE, AND DANCE AT COLORADO
25 STATE UNIVERSITY (CSU); AND

27 **PARAGRAPH 4:** WHEREAS, DR. QUEEN WAS INSTRUMENTAL IN ADVANCING THE
28 PROFILE OF THE DEPARTMENT BY SECURING \$2 MILLION IN
29 GIFTS AND PLEDGES, INCLUDING 10 NEW ENDOWED
30 SCHOLARSHIPS FOR STUDENTS WHILE AT CSU; AND

52 STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON
53 LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE
54 PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON
55 THE DATE OF SUCH APPROVAL.
