10 **TO URGE AND REQUEST THE OFFICE OF PARKING AND TRANSPORTATION TO LOOK**
11 **INTO INSTALLING A SYSTEM OF LIGHTED CROSSWALKS IN DESIGNATED PROBLEM**

14 **PARAGRAPH 1:** WHEREAS, STUDENT SAFETY IS AN INCREASINGLY IMPORTANT
15 ISSUE; AND

17 **PARAGRAPH 2:** WHEREAS, THESE LIGHTED CROSSWALK SYSTEMS HAVE BEEN
18 PROVEN TO DECREASE THE AMOUNT OF PEDESTRIAN-RELATED
19 ACCIDENTS; AND

21 **PARAGRAPH 3:** WHEREAS, LIGHTED CROSSWALKS PROVIDE STUDENTS WITH A
22 SAFE ROUTE TO TRAVEL ACROSS CAMPUS; AND



24 **PARAGRAPH 4:** WHEREAS, THE PROBLEM AREAS WILL BE DESIGNATED BY THE
25 COMMITTEE ON CAMPUS AFFAIRS AND SUSTAINABILITY IN

27 TRANSPORTATION.

29 **PARAGRAPH 5:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA
30 STATE UNIVERSITY STUDENT SENATE THAT THE OFFICE
31 OF PARKING AND TRANSPORTATION LOOK INTO INSTALLING
32 LIGHTED CROSSWALKS IN DESIGNATED PROBLEM AREAS TO
33 ENSURE THE SAFETY OF STUDENTS, AND

35 **PARAGRAPH 6:** BE IT FURTHER RESOLVED THAT A COPY OF THIS
36 RESOLUTION BE TRANSMITTED TO JEFF CAMPBELL,
37 DIRECTOR OF PARKING AND TRANSPORTATION

39 **PARAGRAPH 7:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A
40 SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU
41 STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON
42 LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE
43 PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON
44 THE DATE OF SUCH APPROVAL.
