**A RESOLUTION**

**TO URGE THE OFFICE OF ACADEMIC AFFAIRS TO IMPLEMENT  
A POLICY PROHIBITING COURSEWORK FROM BEING  
ASSIGNED AND/OR DUE DURING TIMES OF CAMPUS CLOSURE AS DESIGNATED  
BY THE LSU ACADEMIC CALENDAR**

- PARAGRAPH 1:** WHEREAS, STUDENTS WORK DILIGENTLY TO COMPLETE ALL CLASS ASSIGNMENTS DURING THE ACADEMIC YEAR; AND
- PARAGRAPH 2:** WHEREAS, IT IS IMPORTANT FOR STUDENTS TO RECEIVE PERIODS OF REST THROUGHOUT THE ACADEMIC YEAR; AND
- PARAGRAPH 3:** WHEREAS, DURING CAMPUS CLOSURE MANY STUDENTS TRAVEL AND DO NOT HAVE ACCESS TO CLASS MATERIALS; AND
- PARAGRAPH 4:** WHEREAS, DURING CAMPUS CLOSURE, MANY ON-CAMPUS RESOURCES ARE NOT AVAILABLE TO STUDENTS; AND
- PARAGRAPH 5:** WHEREAS, MANY STUDENTS HAVE COURSEWORK ASSIGNED AND/OR DUE DURING TIMES OF PLANNED CAMPUS CLOSURE; AND
- PARAGRAPH 6:** WHEREAS, THIS POLICY DOES NOT INCLUDE WEEKENDS, AND DURING PERIODS OF UNPLANNED CAMPUS CLOSURE THE SENIOR COLLEGE DEANS HAVE DISCRETION OVER WHETHER ASSIGNMENTS CAN BE ASSIGNED AND/OR DUE; AND
- PARAGRAPH 7:** WHEREAS, 'ASSIGNED' IS DEFINED AS THE ACTION OF THE ASSIGNING COURSEWORK DURING THE PERIOD OF PLANNED CAMPUS CLOSURE, AND 'DUE' IS DEFINED AS AN ASSIGNMENT BEING DESIGNATED TO TURN IN DURING THE TIME OF PLANNED CLOSURE.
- PARAGRAPH 8:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT



**PARAGRAPH 9:** BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO DR. STUART BELL, EXECUTIVE VICE CHANCELLOR & PROVOST AND DR. T. GILMOUR REEVE, VICE PROVOST.

**PARAGRAPH 10:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
