A RESOLUTION

TO URGE AND REQUEST LSU AUXILIARY SERVICES TO PLACE HAND SANITIZER STATIONS IN THE STUDENT UNION TIGER LAIR

WHEREAS, STUDENTS SHOULD HAVE AN ACCESSIBLE MEANS OF MAINTAINING HEALTH AND WELLNESS IN A HIGHLY POPULATED AREA; AND

BEING THAT THE UNION IS VISITED BY A VAST NUMBER OF STUDENTS, GERMS ARE TRANSMITTED EASILY, AND HYGIENE WHEN CONSUMING FOOD SHOULD BE A CONCERN AMONG THE STUDENT BODY; AND


WHEREAS, AUXILIARY SERVICES SHOULD PLACE HAND SANITIZER STATIONS AMONG THE FOOD COURT TO PROMOTE STUDENT HEALTH AND WELLNESS.

THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT AUXILIARY SERVICES PLACE HAND SANITIZER STATIONS IN THE FOOD COURT, AND

BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO MARGOT CARROLL, EXECUTIVE DIRECTOR OF LSU AUXILIARY SERVICES.

THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY ((1/2)+1) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
