10 TO URGE AND REQUEST FACILITY SERVICES TO REEVALUATE THE SEATING OPTIONS
11 IN THE LSU STUDENT UNION.

13 **PARAGRAPH 1:** WHEREAS, MANY STUDENTS CHOOSE TO DINE, CONGREGATE, AND
14 STUDY IN THE LSU STUDENT UNION; AND

16 **PARAGRAPH 2:** WHEREAS, THE AMOUNT OF AVAILABLE SEATING IN THE UNION
17 DOES NOT ADEQUATELY ACCOUNT FOR THE ABUNDANCE OF
18 STUDENTS IN SEARCH OF SEATING; AND

20 **PARAGRAPH 3:** WHEREAS, ADDITIONAL SEATING WOULD ALSO AID IN
21 ALLEVIATING TRAFFIC FROM PATRONS ATTEMPTING TO FIND A
22 SEAT IN THE UNION; AND

23
24 **PARAGRAPH 4:** WHEREAS, MANY CURRENT SEATING LOCATIONS COULD
25 POTENTIALLY BE IMPROVED FOR MAXIMUM SEATING CAPACITY
26 AND COMFORT; AND

27
28 **PARAGRAPH 5:** WHEREAS, LOCATIONS FOR EXTRA SEATING MAY INCLUDE THE
29 THIRD FLOOR BALCONY, ALONG THE HALLWAY BEHIND ON THE
30 GEAUX ON THE SECOND-FLOOR, ACROSS FROM THE McDONALD'S
31 ON THE FIRST FLOOR, AND ACROSS FROM THE ATM'S ON THE
32 FIRST FLOOR OF THE LSU STUDENT UNION.



34 **PARAGRAPH 6:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA
35 STATE UNIVERSITY STUDENT SENATE THAT LSU
36 AUXILIARY SERVICES EXPLORE ADDITIONAL SEATING OPTIONS
37 FOR THE LSU STUDENT UNION, AND

39 **PARAGRAPH 7:** BE IT FURTHER RESOLVED THAT A COPY OF THIS
40 RESOLUTION BE TRANSMITTED TO MARGOT CARROLL,
41 EXECUTIVE DIRECTOR OF LSU AUXILIARY SERVICES, AND TONY
42 LOMBARDO, DIRECTOR OF FACILITY SERVICES.

44 **PARAGRAPH 8:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A
45 SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU
46 STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON
47 LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE
48 PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON
49 THE DATE OF SUCH APPROVAL.
