8 **TO ESTABLISH A COMMITTEE TO REEVALUATE AND OVERSEE THE ALLOCATION OF THE**
9 **GRADUATE ORGANIZATIONAL RELIEF FUND (ORF)**

10 **PARAGRAPH 1:** WHEREAS, THE FIRST DUTY OF THIS COMMITTEE WILL BE TO RE-
11 EVALUATE THE GRADUATE ORF AND HOW IT IS AWARDED TO
12 STUDENTS; AND

13 **PARAGRAPH 2:** WHEREAS, THE PURPOSE OF THIS COMMITTEE WILL BE TO
14 REEVALUATE AND OVERSEE THE ALLOCATION OF THE GRADUATE
15 ORF; AND

16 **PARAGRAPH 3:** WHEREAS, THIS COMMITTEE WILL BE COMPOSED OF THE
17 GRADUATE SCHOOL COLLEGE COUNCIL (GCC) PRESIDENT OR HIS
18 OR HER DESIGNEE, THE GRADUATE STUDENT ASSOCIATION
19 (GSA) PRESIDENT OR HIS OR HER DESIGNEE, ONE
20 REPRESENTATIVE THAT IS A GRADUATE SCHOOL STUDENT
21 SENATOR, AND AT LEAST THREE (3) GRADUATE STUDENTS
22 UNAFFILIATED WITH GCC, GSA OR STUDENT GOVERNMENT, TO
23 BE APPOINTED BY THE STUDENT BODY PRESIDENT.

24 **PARAGRAPH 4:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA
25 STATE UNIVERSITY STUDENT SENATE THAT A
26 COMMITTEE BE ESTABLISHED TO REEVALUATE AND OVERSEE THE
27 ALLOCATION OF THE GRADUATE ORF, AND

28 **PARAGRAPH 5:** BE IT FURTHER RESOLVED THAT A COPY OF THIS
29 RESOLUTION BE TRANSMITTED TO OLIVIA OLINDE,
30 GRADUATE SCHOOL COLLEGE COUNCIL PRESIDENT; MELVIN
31 JACKSON, GRADUATE STUDENT ASSOCIATION PRESIDENT; DR.
32 GARY BYERLY, DEAN OF THE GRADUATE SCHOOL; AND CAROL
33 ADAMS, ADMINISTRATIVE PROGRAM SPECIALIST FOR THE
34 GRADUATE SCHOOL..

35 **PARAGRAPH 6:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A
36 SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU
37 STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON
38 LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE
39 PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON
40 THE DATE OF SUCH APPROVAL.
