9 **A RESOLUTION**

10 **TO URGE AND REQUEST LSU AUXILIARY SERVICES TO ALLOW LSU UNIVERSITY**  
11 **RECREATION TO TEMPORARILY UTILIZE THE FORMER BILLIARDS SPACE IN THE LSU**  
12 **STUDENT UNION**

14 **PARAGRAPH 1:** WHEREAS, THERE IS CURRENTLY NO OCCUPANT IN THE FORMER  
15 BILLIARDS SPACE IN THE LSU STUDENT UNION, AND LSU  
16 UNIVERSITY RECREATION HAS SHOWN GREAT INTEREST IN USING  
17 THE AREA; AND

19 **PARAGRAPH 2:** WHEREAS, UNTIL BIDDING AND SELECTION FOR THE NEXT  
20 OCCUPANT OF THE SPACE IS COMPLETE, LSU UNIVERSITY  
21 RECREATION COULD HAVE ACCESS TO THIS SPACE TO USE AS THEY  
22 PLEASE; AND

24 **PARAGRAPH 3:** WHEREAS, MANY STUDENTS SPEND THEIR FREE TIME IN THE LSU  
25 STUDENT UNION AND DO NOT HAVE TIME TO GO ALL THE WAY  
26 TO THE STUDENT RECREATION CENTER DURING THEIR BUSY  
27 DAYS; AND

29 **PARAGRAPH 4:** WHEREAS, THIS WOULD HELP PROMOTE AN ACTIVE LIFESTYLE BY  
30 ALLOWING STUDENTS THE CONVENIENT OPTION TO ENGAGE IN  
31 AN ACTIVITY BEFORE, AFTER, OR BETWEEN CLASSES.

33 **PARAGRAPH 5:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA  
34 STATE UNIVERSITY STUDENT SENATE THAT LSU  
35 AUXILIARY SERVICES ALLOW LSU UNIVERSITY RECREATION TO  
36 TEMPORARILY UTILIZE THE FORMER BILLIARDS SPACE IN THE  
37 LSU STUDENT UNION, AND

39 **PARAGRAPH 6:** BE IT FURTHER RESOLVED THAT A COPY OF THIS  
40 RESOLUTION BE TRANSMITTED TO LAURIE BRADEN,  
41 DIRECTOR OF LSU UNIVERSITY RECREATION, AND MARGOT  
42 CARROLL, DIRECTOR OF AUXILIARY SERVICES.

44 **PARAGRAPH 7:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A  
45 SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU  
46 STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON  
47 LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE  
48 PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON  
49 THE DATE OF SUCH APPROVAL.
