13 **PARAGRAPH 1:** WHEREAS, LSU POLICY STATEMENT 29 MANDATES
14 THAT THE SYLLABUS PROVIDES INFORMATION
15 "INCLUDING COURSE OBJECTIVES, GRADING POLICIES,
16 TOPICS, TEXTBOOKS, AND REFERENCE MATERIALS,"

19 **PARAGRAPH 2:** WHEREAS, LSU POLICY STATEMENT 45 REQUIRES A
20 SYLLABUS TO BE SUBMITTED TO AND APPROVED BY
21 THE COURSES AND CURRICULA COMMITTEE OF THE
22 LSU FACULTY SENATE AND THE LSU OFFICE OF
23 ACADEMIC AFFAIRS IN ORDER TO ESTABLISH ANY
24 GIVEN COURSE, AND;

26 **PARAGRAPH 3:** WHEREAS, THE HIGHER EDUCATION OPPORTUNITY
27 ACT OF 2008 PASSED BY THE US CONGRESS
28 MANDATES THAT "HIGHER EDUCATION
29 INSTITUTIONS ARE REQUIRED, TO THE MAXIMUM
30 EXTENT PRACTICABLE, TO LIST THE PRICES AND
31 ISBN CODES OF THE REQUIRED AND RECOMMENDED
32 TEXTBOOKS FOR EACH COURSE ON THEIR ONLINE
33 COURSE SCHEDULES USED FOR PREREGISTRATION

44 AND PROGRAMS WILL MAKE THE CLASS COURSE
45 SYLLABUS OF THE MOST RECENT OFFERING OF EACH
46 COURSE UNDER EACH INSTRUCTOR READILY

PARAGRAPH 7: WHEREAS, STUDENTS SHOULD HAVE ACCESS TO
DETAILED COURSE INFORMATION WHEN MAKING
DECISIONS ABOUT WHICH CLASSES TO SCHEDULE,
AND;

PARAGRAPH 8: WHEREAS, ALLOWING STUDENTS TO BROWSE
SYLLABI OF POTENTIAL COURSE S COULD BETTER
SERVE THEIR INTERESTS, NEEDS AND EDUCATION,
AND;

PARAGRAPH 9: WHEREAS, A CENTRAL SYLLABUS DATABASE WOULD
ALSO PROVIDE CONVENIENT ACCESS TO THIRD-

OF SYLLABI FOR ALL COURSES OF INSTRUCTION AT
THE UNIVERSITY.

REEVE, VICE PROVOST FOR ACADEMIC AFFAIRS;
BRIAN T. NICHOLS, CHIEF INFORMATION OFFICER;
AND ROBERT K. DOOLOS, UNIVERSITY REGISTRAR.
