9 **TO SUPPORT THE LOUISIANA STATE UNIVERSITY (LSU) POLICE DEPARTMENT IN ITS**
10 **RESEARCH AND DEVELOPMENT OF A SECURITY APPLICATION FOR COMPUTERS AND**
11 **SMARTPHONES FOR THE LSU COMMUNITY;**

14 **PARAGRAPH 1:** WHEREAS, CALL BOXES LOCATED AROUND THE LSU CAMPUS ARE
15 SELDOM USED AND SPORADICALLY PLACED AND ARE THEREFORE
16 OFTEN INEFFECTIVE IN MINISTERING TO STUDENTS REQUIRING
17 IMMEDIATE ASSISTANCE FROM THE POLICE DEPARTMENT; AND

19 **PARAGRAPH 2:** WHEREAS, WITH EVER EXPANDING TECHNOLOGY, SMARTPHONES,
20 AND TABLETS HAVE BEEN HEAVILY INTEGRATED INTO THE LIVES
21 OF STUDENTS AS WELL AS FACULTY AND STAFF; AND

23 **PARAGRAPH 3:** WHEREAS, SMARTPHONES AND TABLETS ARE ONE OF THE MOST
24 EFFECTIVE AND READILY AVAILABLE FORMS OF COMMUNICATION
25 FOR STUDENTS; AND

27 **PARAGRAPH 4:** WHEREAS, A SECURITY APPLICATION AVAILABLE FOR DOWNLOAD
28 ON SMARTPHONES, TABLETS, AND DESKTOPS COULD AID
29 STUDENTS, FACULTY, STAFF AND VISITORS IN BOTH EMERGENCY
30 AND NON-EMERGENCY SITUATIONS BY GIVING THEM A DIRECT
31 AND EXPEDIENT CONNECTION TO LSU POLICE; AND

33 **PARAGRAPH 5:** WHEREAS, THE LSU COMMUNITY HAS A NEED FOR A RELIABLE
34 SECURITY APPLICATION TO OFFER A VARIETY OF CAPABILITIES
35 SUCH AS PINPOINTING EXACT LOCATIONS, UPLOADING VIDEOS
36 AND PHOTOS, DIRECT MESSAGING WITH OFFICIALS, AND
37 CREATING PERSONALIZED USER PROFILES; AND

39 **PARAGRAPH 6:** WHEREAS, AN APPLICATION THAT COULD BENEFIT STUDENTS
40 BOTH ON AND OFF CAMPUS WOULD GIVE STUDENTS BETTER
41 PROTECTION AND SECURITY DURING ALL HOURS OF THE DAY; AND


43 **PARAGRAPH 7:** WHEREAS, THIS APPLICATION WOULD IDEALLY BE FREE OF

46 MOBILE DEVICE OR COMPUTER SOFTWARE.

48 **PARAGRAPH 8:** THEREFORE, BE IT RESOLVED THAT THE LOUISIANA
49 STATE UNIVERSITY AND AGRICULTURAL AND
50 MECHANICAL COLLEGE STUDENT SENATE SUPPORTS
51 THE LSU POLICE DEPARTMENT IN THEIR CONTINUED SEARCH
52 FOR A SECURITY APPLICATION FOR THE LSU COMMUNITY.


54 **PARAGRAPH 9:** BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE
55 TRANSMITTED TO LAWRENCE RABALAIS, CHIEF OF POLICE, LSU

57 DEPARTMENT; AND D'ANN MORRIS, DIRECTOR OF THE
58 EMERGENCY OPERATIONS CENTER.
