16 FOR INDIVIDUAL OFF-CAMPUS STUDY OF THE LOUISIANA STATE
17 UNIVERSITY AND AGRICULTURAL AND MECHANICAL COLLEGE
18 (LSU) WAS ESTABLISHED MAY 10, 1976 AND;

21 HAVE DRASTICALLY EVOLVED OVER THE LAST 37 YEARS NOW
