A RESOLUTION**TO CREATE THE TEMPORARY TASK FORCE ON UNIVERSITY CENTER FOR ADVISING
AND COUNSELING**

PARAGRAPH 1: WHEREAS, THIS TASK FORCE WOULD MEET TO DISCUSS THE UNIVERSITY CENTER FOR ADVISING AND COUNSELING (UCAC) AND TO REEVALUATE THE STUDENT EXPERIENCE;

PARAGRAPH 2: WHEREAS, THIS TASK FORCE WOULD BE MADE UP OF:

- THE DIRECTOR OF ACADEMIC AFFAIRS, OR HIS OR HER DESIGNEE;
- THE ASSISTANT DIRECTOR OF ACADEMIC AFFAIRS, OR HIS OR HER DESIGNEE;
- CHAIR OF THE COMMITTEE ON ACADEMIC AFFAIRS, OR HIS OR HER DESIGNEE;
- VICE CHAIR OF THE COMMITTEE ON ACADEMIC AFFAIRS, OR HIS OR HER DESIGNEE;
- THREE (3) SENATORS FROM UCAC ELECTED BY THE STUDENT SENATE
- THE PRESIDENT OF THE UCAC COLLEGE COUNCIL, OR HIS OR HER DESIGNEE;
- THE EXECUTIVE DIRECTOR OF UNIVERSITY COLLEGE OR HIS OR HER DESIGNEE;

PARAGRAPH 3: WHEREAS, THE FIRST ORDER OF BUSINESS OF THIS TASK FORCE SHALL BE TO ELECT THE CHAIR OF THE COMMITTEE; AND

PARAGRAPH 4: WHEREAS, THE FINDINGS AND FINAL VOTES OF THIS TASK FORCE SHALL BE PRESENTED TO THE STUDENT SENATE IN THE FORM OF LEGISLATION.

PARAGRAPH 5: THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE STUDENT SENATE CREATES THE TEMPORARY TASK FORCE ON UNIVERSITY CENTER FOR ADVISING AND COUNSELING

PARAGRAPH 6: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO PAUL IVEY, EXECUTIVE DIRECTOR OF THE UNIVERSITY COLLEGE; GIL REEVE, VICE PROVOST FOR PROGRAMS, PLANNING, AND REVIEW.

PARAGRAPH 7: THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE

AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
