A FINANCE BILL

TO ALLOCATE A MAXIMUM OF FIVE THOUSAND ONE HUNDRED TWENTY THREE DOLLARS AND EIGHTY-FIVE CENTS (\$5,123.85) FROM THE STUDENT GOVERNMENT SURPLUS ACCOUNT TO FUND COMPUTERS AND SOFTWARE FOR STUDENT GOVERNMENT BRANCH OFFICES.

- PARAGRAPH 1:** WHEREAS, THE CURRENT COMPUTERS AND SOFTWARE AVAILABLE IN THE OFFICES OF THE EXECUTIVE, LEGISLATIVE, AND JUDICIAL BRANCH OFFICES ARE OLD AND UNRELIABLE; AND
- PARAGRAPH 2:** WHEREAS, STUDENT GOVERNMENT DOES AN ENORMOUS AMOUNT OF WORK ON THESE COMPUTERS IN ORDER TO SERVE THEIR RESPECTIVE BRANCHES; AND
- PARAGRAPH 3:** WHEREAS, PROPER TECHNOLOGY TO ACCOMPLISH THESE TASKS ARE IMPERATIVE TO FUNCTION; AND
- PARAGRAPH 4:** WHEREAS, THIS EXPENDITURE WOULD COVER THE FOLLOWING ACQUISITIONS:
1. (1) IMAC 21.5 INCH: 1,239.00;
 2. (5) DELL OPTI PLEX 3010 MINI TOWER N SERIES: 3,361.15;
 3. (1) ADOBE CREATIVE SUITE 6 DESIGN STANDARD LICENSE: 458.81;
 4. (1) ADOBE ACROBAT X PRO-(v.10) LICENSE: 64.89;
- PARAGRAPH 5:** WHEREAS, ACCESS OF THE IMAC WILL BE LIMITED TO THE USE OF THE STUDENT GOVERNMENT GRAPHIC DESIGNER, EXECUTIVE DIRECTOR OF COMMUNICATION, SENATE DIRECTOR OF COMMUNICATION AND THE STUDENT GOVERNMENT ADVISOR; AND
- PARAGRAPH 6:** WHEREAS, THE PURCHASE OF THE AFORMENTIONED MATERIALS BY STUDENT GOVERNMENT WOULD DIRECTLY IMPACT STUDENTS' KNOWLEDGE OF CURRENT ACTIVITIES AND HELP TO RE-BOLSTER STUDENT GOVERNMENT'S EFFORTS TO UPDATE STUDENTS; AND
- PARAGRAPH 7:** THEREFORE, BE IT ENACTED BY THE STUDENT SENATE OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE THAT A MAXIMUM OF FIVE THOUSAND ONE HUNDRED TWENTY THREE DOLLARS AND EIGHTY FIVE CENTS (\$5,123.85) BE ALLOCATED FROM THE STUDENT GOVERNMENT SURPLUS ACCOUNT TO FUND COMPUTERS AND SOFTWARE FOR THE USE BY THE STUDENT GOVERNMENT OFFICES.

PARAGRAPH 8: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
