9 **TO ALLOCATE A MAXIMUM OF FOUR THOUSAND TWO HUNDRED DOLLARS (\$4,200)**
10 **FROM THE STUDENT GOVERNMENT SENATE CONTINGENCY ACCOUNT TO THE**
11 **RESIDENCE HALL ASSOCIATION TO FUND THE SNOWING IN THE SOUTH PROGRAM**

14 **PARAGRAPH 1:** WHEREAS, THE RESIDENCE HALL ASSOCIATION (RHA) HOSTS MANY
15 PROGRAMS FOR STUDENTS LIVING WITHIN THE RESIDENCE HALLS ON
16 CAMPUS, AND

18 **PARAGRAPH 2:** WHEREAS, SNOWING IN THE SOUTH WAS AN ANNUAL PROGRAM
19 UNTIL RHA COULD NO LONGER AFFORD TO HOST THE PROGRAM, AND

21 **PARAGRAPH 3:** WHEREAS, THE COMPANY PROVIDING SNOW FOR THE EVENT HAS
22 SIGNIFICANTLY REDUCED THE PRICE OF THEIR SERVICES, AND

24 **PARAGRAPH 4:** WHEREAS, THE RHA BUDGET HAS EXPERIENCED CUTS SINCE THE
25 TIME THIS PROGRAM WAS REMOVED AND THE ORGANIZATION
26 BECAME LESS ACTIVE, AND

28 **PARAGRAPH 5:** WHEREAS, THE CURRENT RHA ADMINISTRATION IS TRYING TO
29 EXPAND THEIR ORGANIZATION TO RECEIVE MORE FUNDING FROM
30 THE DEPARTMENT OF RESIDENTIAL LIFE AND BECOME A MORE
31 ACTIVE ORGANIZATION FOR STUDENTS LIVING ON CAMPUS, AND

33 **PARAGRAPH 6:** WHEREAS, THE RHA HAS AGREED TO OPEN THE EVENT TO THE
34 UNIVERSITY PUBLIC.

36 **PARAGRAPH 7:** WHEREAS, THIS ORGANIZATION CAN HELP STUDENTS LIVING ON
37 CAMPUS DEVELOP LEADERSHIP SKILLS AND PROVIDE OPPORTUNITIES
38 TO ENTER INTO OTHER STUDENT ORGANIZATIONS.

40 **PARAGRAPH 8:** THEREFORE, BE IT RESOLVED THAT THE LOUISIANA
41 STATE UNIVERSITY AGRICULTURAL AND MECHANICAL
42 COLLEGE STUDENT SENATE ALLOCATE A MAXIMUM OF FOUR
43 THOUSAND TWO HUNDRED DOLLARS AND ZERO CENTS TO THE
44 RESIDENCE HALL ASSOCIATION IN ORDER TO PARTIALLY FUND THE
45 SNOWING IN THE SOUTH PROGRAM.

47 **PARAGRAPH 9:** BE IT FURTHER RESOLVED THAT A COPY OF THIS
48 RESOLUTION BE FORWARDED TO DIRECTOR OF RESIDENTIAL
49 LIFE STEVEN WALLER, RESIDENCE HALL ASSOCIATION ADVISOR
50 DOUGLAS ASHCROFT, AND RESIDENCE HALL ASSOCIATION
51 PRESIDENT KELSEY LEBLANC.

53 **PARAGRAPH 10:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY
54 (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE
55 PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF
56 VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE
57 SENATE, ON THE DATE OF SUCH APPROVAL.
